3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER OR DESIGNEE TO EXECUTE A CONTRACT
6 WITH THE ALPHA & OMEGA GROUP SECURITY
7 SERVICES, INC., FOR PROVIDING SECURITY GUARD
8 SERVICES, ON THE SAME TERMS AND CONDITIONS
9 AFFORDED TO THE COUNTY OF ORANGE, IN AN
10 ANNUAL AMOUNT OF \$1,800,000, WITH A 20%
11 CONTINGENCY OF \$360,000, FOR A TOTAL NOT TO
12 EXCEED ANNUAL AMOUNT OF \$2,160,000, UNTIL THE
13 COUNTY OF ORANGE CONTRACT EXPIRES ON MARCH
14 31, 2025, WITH THE OPTION TO RENEW FOR AS LONG
15 AS THE COUNTY OF ORANGE CONTRACT IS IN EFFECT,
16 AT THE DISCRETION OF THE CITY MANAGER

18 WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the
19 City Manager to enter into a contract on behalf of the City, in writing or otherwise, without
20 advertising for bids, for services, supplies, materials, equipment or labor, with other
21 government agencies, when authorized by resolution; and

22 WHEREAS, various City Departments have a need for security guard
23 services; and

24 WHEREAS, the primary role of a security guard is to ensure the safety and
25 security of City employees, visitors, properties, and buildings. Services include, but are not
26 limited to, monitoring parking areas, responding to calls for assistance, and initiating
27 communication to the Police or Fire Departments; and

28 WHEREAS, Security guard services are required at many routine, standing

1 locations throughout the City, but can also be leveraged to respond to as-needed locations
2 that require security guards, such as pop-up vaccination sites or shelters for people
3 experiencing homelessness; and

4 WHEREAS, the Purchasing Division of the Department of Financial
5 Management researched procurement options for security guard services and discovered
6 other agencies had completed open, fair, transparent, and competitive procurement
7 processes; and

8 WHEREAS, the City reviewed the contract options and determined that the
9 contract between the County of Orange, CA and The Alpha & Omega Group Security
10 Services, Inc. for security guard services, Contract No. RCA-017-20010010 ("County of
11 Orange Contract") provided the best value to the City; and

12 WHEREAS, the City's participation in the County of Orange Contract will
13 facilitate timely acquisition of security guard services as well as provide considerable cost
14 benefits to the City; and

15 WHEREAS, if the City had to go to formal bid rather than participate in the
16 County of Orange Contract, considerably more funds would be required;

17 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
18 follows:

19 Section 1. The City Manager or designee is hereby authorized to enter an
20 agreement with The Alpha & Omega Group Security Services, Inc. for security guard
21 services, on the same terms and conditions identified in the County of Orange Contract in
22 an annual amount of One Million Eight Hundred Thousand Dollars (\$1,800,000), plus a
23 twenty percent (20%) contingency in the amount of Three Hundred Sixty Thousand Dollars
24 (\$360,000), for a total annual amount not to exceed Two Million One Hundred Sixty
25 Thousand Dollars (\$2,160,000), until the County of Orange Contract No. RCA-017-
26 20010010 expires on March 31, 2025, with the option to renew for as long as the County
27 of Orange Contract No. RCA-017-20010010 is in effect, at the discretion of the City
28 Manager.
