

RESOLUTION NO. RES-25-0065

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT WITH HYSTER-YALE MATERIALS HANDLING, INC., TO PURCHASE/FURNISH ETC., AN ALL-ELECTRIC HYSTER FORKLIFT, WITH RELATED EQUIPMENT AND ACCESSORIES ON THE SAME TERMS AND CONDITIONS AFFORDED TO SOURCEWELL (THROUGH THEIR CONTRACT WITH HYSTER-YALE MATERIALS HANDLING, INC) IN AN ANNUAL AMOUNT NOT TO EXCEED \$45,384, UNTIL THE SOURCEWELL CONTRACT EXPIRES ON JULY 23, 2028, WITH THE OPTION TO RENEW FOR AS LONG AS THE SOURCEWELL CONTRACT IS IN EFFECT, AT THE DISCRETION OF THE CITY MANAGER

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase and deliver an all-electric Hyster forklift, with related equipment and accessories; and

WHEREAS, Sourcewell has a Contract for the purchase of an all-electric forklift under Contract No. RFP #053024-HYS; and

WHEREAS, the City's participation in the Sourcewell Contract will facilitate the City's ability to purchase/furnish/etc. as well as provide considerable cost benefits to

1 the City; and

2 WHEREAS, if the City had to utilize a formal bid process rather than  
3 participate in the Sourcewell Contract considerably more funds would be required;

4 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
5 follows:

6 Section 1. The above recitals are true and correct and are incorporated  
7 herein by this reference.

8 Section 2. The City Manager or designee is hereby authorized to enter an  
9 agreement with Hyster-Yale Materials Handling, Inc. to purchase/furnish/install an all-  
10 electric Hyster forklift, with related equipment and accessories, of the same type and kind  
11 identified in the Sourcewell Contract except as modified by mutual agreement of the City  
12 and Hyster-Yale Materials Handling, Inc., and the purchase by the City shall be on the  
13 same terms and conditions afforded to Sourcewell in an amount not to exceed Forty-Five  
14 Thousand Three Hundred Eighty-Four Dollars (\$45,384) including tax and shipping, until  
15 the Sourcewell contract expires on July 23, 2028 with the option to renew for as long as  
16 the Sourcewell contract is in effect, at the discretion of the City Manager.

17 Section 3. This resolution shall take effect immediately upon its adoption  
18 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
