RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT INCLUDING AUTHORIZATION TO TRANSFER TITLE FOR BUY BACK EQUIPMENT WITH DELL MARKETING, OF ROUND ROCK, TX, FOR TECHNOLOGY SOLUTIONS, PRODUCTS, AND SERVICES ON THE SAME TERMS AND CONDITIONS AFFORDED TO REGION XIV EDUCATION SERVICE CENTER, THROUGH OMNIA PARTNERS, IN A TOTAL ANNUAL AMOUNT NOT TO EXCEED \$6,187,000, UNTIL THE OMNIA CONTRACT EXPIRES ON NOVEMBER 30, 2025, WITH THE OPTION TO RENEW FOR AS LONG AS THE OMNIA PARTNERS CONTRACT IS IN EFFECT, AT THE DISCRETION OF THE CITY MANAGER

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase technology solutions, products, services IT security, and data protection services; and

WHEREAS, Region XIV Education Service Center through the OMNIA Partners contract, has a Contract/Agreement etc. for the purchase of these technology solutions, products and services, Contract No. 01-143 (“Omnia Contract”); and

WHEREAS, the City’s participation in the Region XIV Education Service Center Contract will facilitate the City’s ability to purchase, as well as provide considerable

1 cost benefits to the City; and

2 WHEREAS, if the City had to utilize a formal bid process rather than  
3 participate in the Omnia Contract considerably more funds would be required;

4 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
5 follows:

6 Section 1. The above recitals are true and correct and are incorporated  
7 herein by this reference.

8 Section 2. The City Manager or designee is hereby authorized to enter an  
9 agreement, including authorization to transfer title for buy back equipment, and any  
10 necessary subsequent amendments, with Dell Marketing, L.P., of Round Rock, TX, to  
11 purchase Technology Solutions, Products, and Services, of the same type and kind  
12 identified in the Region XIV Education Service Center except as modified by mutual  
13 agreement of the City and Dell Marketing, and the purchase by the City shall be on the  
14 same terms and conditions afforded to Region XIV Education Service Center through the  
15 OMNIA Partners contract in an amount not to exceed Six Million One Hundred Eighty-  
16 Seven Thousand Dollars (\$6,187,000) until the OMNIA contract expires on November 30,  
17 2025, with the option to renew for as long as the OMNIA Partners contract is in effect, at  
18 the discretion of the City Manager.

19 Section 3. This resolution shall take effect immediately upon its adoption  
20 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
