RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE A CONTRACT WITH SPECIALIZED ELEVATOR SERVICES, LLC, FOR PROVIDING ELEVATOR MAINTENANCE, REPAIR, AND RELATED SERVICES, ON THE SAME TERMS AND CONDITIONS AFFORDED TO THE LONG BEACH UNIFIED SCHOOL DISTRICT, IN AN ANNUAL AMOUNT OF \$350,000, WITH A 20% CONTINGENCY IN THE AMOUNT OF \$70,000 FOR A TOTAL ANNUAL AMOUNT NOT TO EXCEED \$420,000, UNTIL THE LONG BEACH UNIFIED SCHOOL DISTRICT CONTRACT EXPIRES ON JUNE 30, 2025, WITH THE OPTION TO RENEW FOR AS LONG AS THE LONG BEACH UNIFIED SCHOOL DISTRICT CONTRACT IS IN EFFECT, AT THE DISCRETION OF THE CITY MANAGER

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City Manager to enter into a contract on behalf of the City, in writing or otherwise, without advertising for bids, services, supplies, materials, equipment or labor, with other government agencies, when authorized by resolution; and

WHEREAS, the City requires as-needed elevator maintenance, repair, and related services for City elevators at various locations; and

WHEREAS, the Purchasing Division of the Department of Financial Management researched procurement options for elevator maintenance, repair, and related services and discovered other agencies had completed open, fair, transparent, and

1 competitive procurement processes; and

2 WHEREAS, the City reviewed the contract options and determined that the
3 contract between the Long Beach Unified School District and Specialized Elevator
4 Services, LLC, Contract No. 2122-0429-00 (“LBUSD Contract”) provided the best value to
5 the City; and

6 WHEREAS, the City’s participation in the LBUSD Contract will facilitate timely
7 acquisition of the as-needed elevator maintenance, repair, and related services as well as
8 provide considerable cost benefits to the City; and

9 WHEREAS, if the City had to go to formal bid rather than participate in the
10 LBUSD Contract, considerably more funds would be required;

11 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
12 follows:

13 Section 1. The City Manager or designee is hereby authorized to enter an
14 agreement with Specialized Elevator Services, LLC for as-needed elevator maintenance,
15 repair, and related services, on the same terms and conditions identified in the LBUSD
16 Contract in an annual amount of Three Hundred Fifty Thousand Dollars (\$350,000), plus a
17 twenty percent (20%) contingency in the amount of Seventy Thousand Dollars (\$70,000),
18 for a total annual contract amount not to exceed Four Hundred Twenty Thousand Dollars
19 (\$420,000), until the LBUSD contract expires on June 30, 2025, with the option to renew
20 for as long as the LBUSD contract is in effect, at the discretion of the City Manager.

21 Section 2. This resolution shall take effect immediately upon its adoption
22 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
