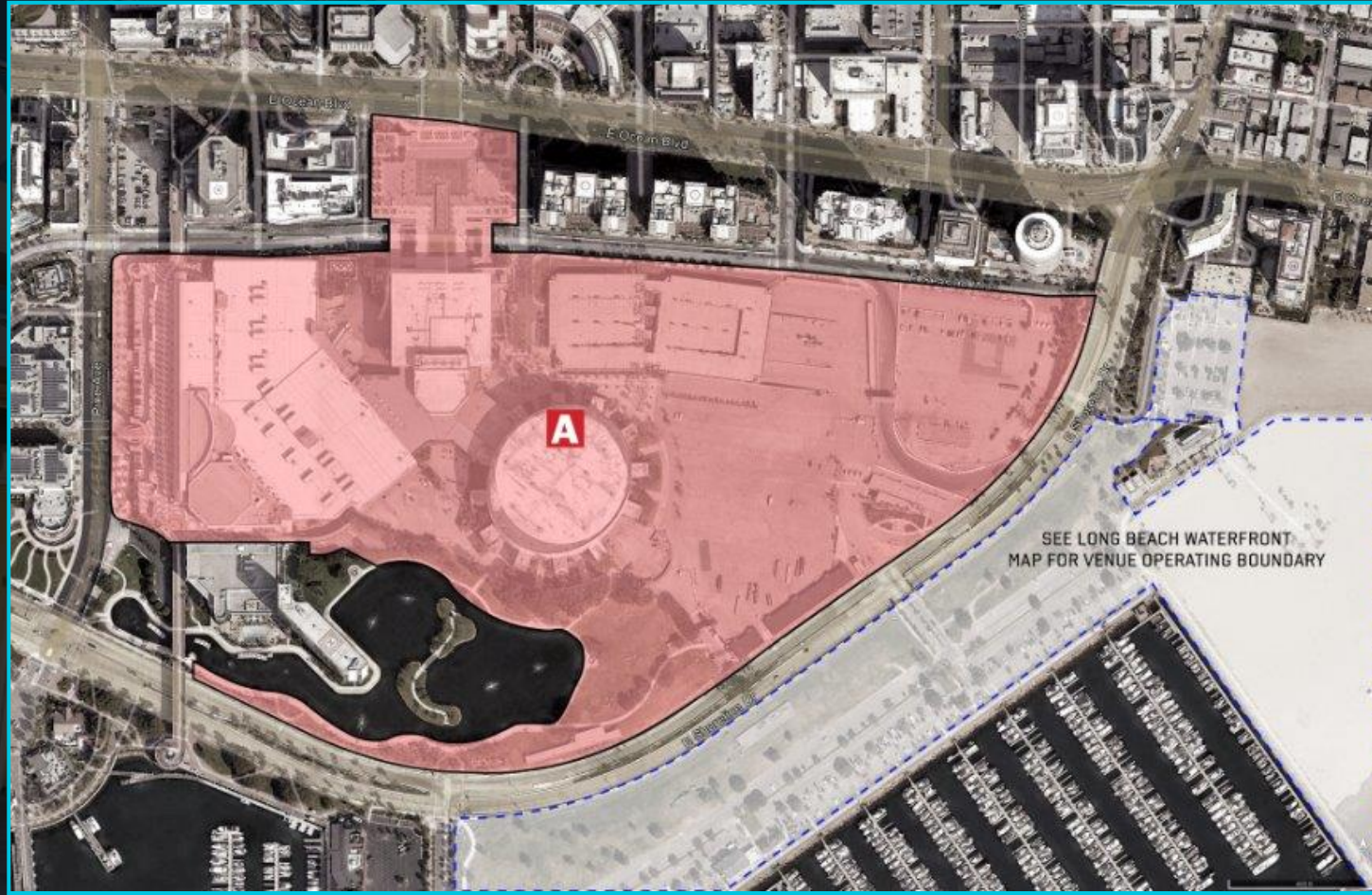
Purpose

- Outline venue terms and conditions, including maps, use periods, and cost recovery.

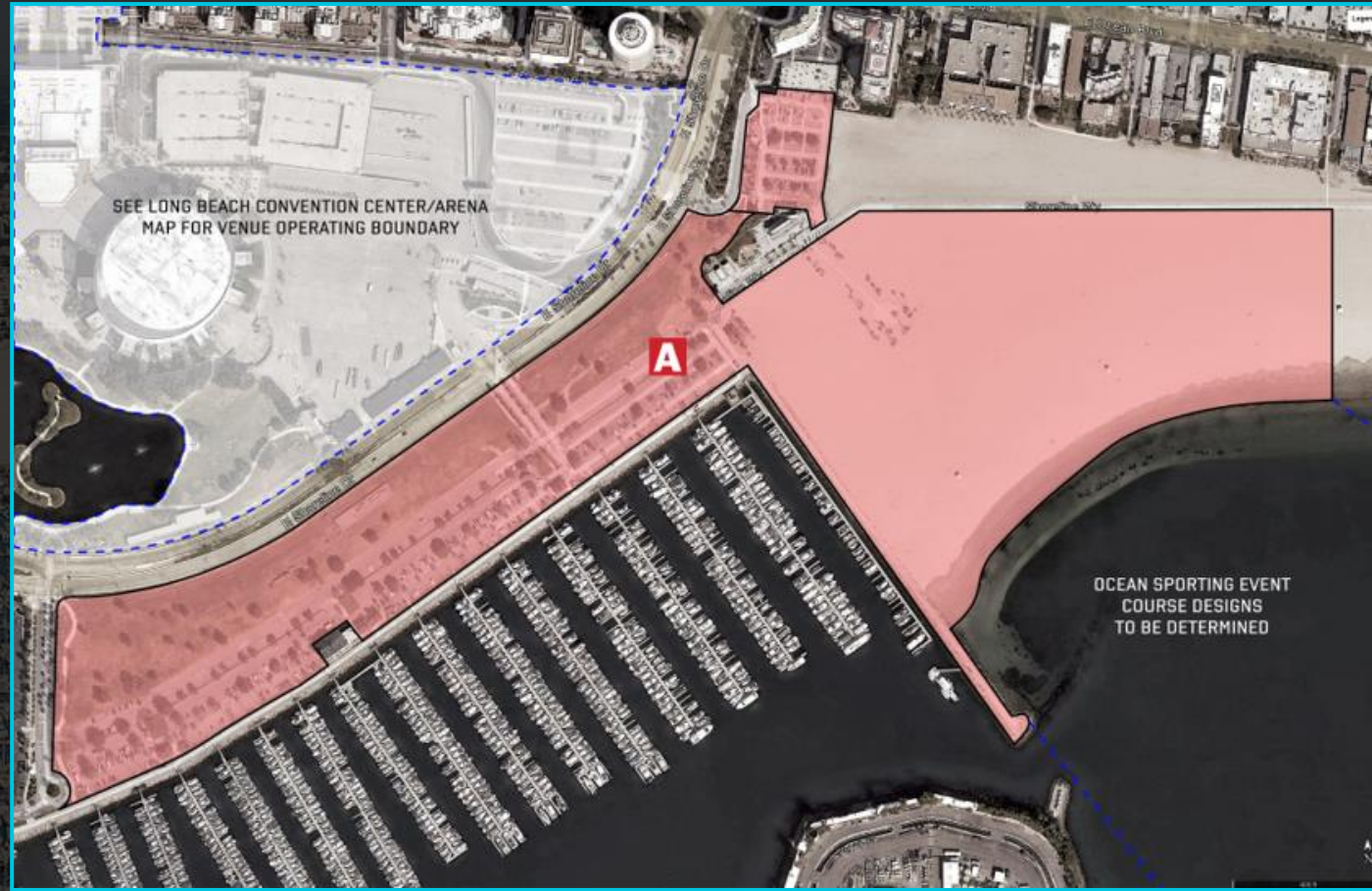

Commitments

- In addition to the venues and use periods, the Venue Use Guarantee outlines key cost and reimbursement provisions.
- LA28 will reimburse all operational costs associated with the production of the Games above normal and customary services the City provides.
- The City also commits to helping accommodate test events in the lead up to the 2028 Olympic and Paralympic Games.

Next Steps – The Games Plan

- Following the Venue Use Guarantee, LA28 is expected to finalize the Games schedule with the International Olympic Committee and the City of Los Angeles this summer.
- This will outline the venues and games host in Long Beach and throughout the LA28 venues.
- Cost recovery expectations, including rent and services at each venue, will be outlined in Venue Services Agreements, to be negotiated by 2027.

Next Steps – Coastal Review

- The City agrees to partner with LA28 to secure permits for the Games through the California Coastal Commission.
- Venue operations, including temporary site builds and decommissioning, will be managed by LA28 and require approval from the California Coastal Commission.
- Coastal review may change venue footprints, phasing timelines, and use periods, in an effort to minimize impacts on access to public beaches.

Next Steps – Community Outreach

- As LA28 develops its plan for each venue and undergoes the Coastal permitting process, further details on resident and business impacts and access to public space will be available.
- Staff will conduct community outreach to discuss potential impacts on residents and businesses as more information becomes available.
- The objective is to keep the community well-informed about mitigation efforts and ensure the Games provide a positive experience for all.
- A Frequently Asked Questions document is available, providing initial insights into potential resident impacts.
