RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE A CONTRACT WITH FERGUSON ENTERPRISES, LLC DBA FERGUSON FACILITIES SUPPLY, FOR FURNISHING AND DELIVERING AS-NEEDED PLUMBING AND VARIOUS SUPPLIES, ON THE SAME TERMS AND CONDITIONS AFFORDED TO THE COUNTY OF ORANGE, IN AN ANNUAL AMOUNT OF \$725,000, WITH A 20% CONTINGENCY OF \$145,000, FOR A TOTAL NOT TO EXCEED ANNUAL AMOUNT OF \$870,000, UNTIL THE COUNTY OF ORANGE CONTRACT EXPIRES ON FEBRUARY 10, 2029, WITH THE OPTION TO RENEW FOR AS LONG AS THE COUNTY OF ORANGE CONTRACT IS IN EFFECT, AT THE DISCRETION OF THE CITY MANAGER

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City Manager to enter into a contract on behalf of the City, in writing or otherwise, without advertising for bids, for services, supplies, materials, equipment or labor, with other government agencies, when authorized by resolution; and

WHEREAS, various departments within the City of Long Beach require plumbing and various supplies; and

WHEREAS, Ferguson Enterprises, LLC dba Ferguson Facilities Supply, has a contract with the County of Orange, California for plumbing and various supplies, Contract No. MA-080-23011696 (“County of Orange Contract”); and

WHEREAS, the City’s participation in the County of Orange Contract will

1 facilitate timely acquisition of the as-needed plumbing and various supplies as well as
2 provide considerable cost benefits to the City; and

3 WHEREAS, if the City had to go to formal bid rather than participate in the
4 County of Orange Contract, considerably more funds would be required;

5 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
6 follows:

7 Section 1. The City Manager or designee is hereby authorized to enter an
8 agreement with Ferguson Enterprises LLC dba Ferguson Facilities Supply for as-needed
9 plumbing and various supplies, on the same terms and conditions identified in the County
10 of Orange Contract in an annual amount of Seven Hundred Twenty-Five Thousand Dollars
11 (\$725,000) with a twenty percent (20%) contingency of One Hundred Forty-Five Thousand
12 Dollars (\$145,000) for a total not to exceed annual amount Eight Hundred Seventy
13 Thousand Dollars (\$870,000), until the County of Orange Contract No. MA-080-23011696
14 expires on February 10, 2029, with the option to renew for as long as the County of Orange
15 Contract No. MA-080-23011696 is in effect, at the discretion of the City Manager.

16 Section 2. This resolution shall take effect immediately upon its adoption
17 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
