The Department of Financial Management recommends the **approval** of the Entertainment Permit for **Bite Catering Couture, LLC (a California Limited Liability Company DBA Bite Catering Couture** ("Permittee") for the premises located at 440 Elm Avenue, Long Beach, CA 90802 ("Premises") subject to the following conditions:

I. STANDARD CONDITIONS OF OPERATION

The entertainment activities at the Premises shall be limited to those activities and elements expressly indicated on the Entertainment Permit Application, the conditions provided below and separately by the Long Beach Police Department, and as approved by the City Council. Any change in the entertainment activities, which exceed the conditions of the approved permit, will require that a new permit application be submitted to the City Council for their review and approval.

- 1) Unless separately applied for, reviewed, and approved, no adult entertainment, as defined by Section 21.15.110 LBMC, shall be conducted on the permitted premises.
- 2) The permittee shall comply with the requirements of LBMC Sec. 8.80 (Noise) at all times.
- 3) This Entertainment Permit is an accessory permit to the primary business license. In the event the primary business ceases operation, the Entertainment Permit becomes null and void.
- 4) The permittee shall maintain full compliance with all applicable laws, including all local, state, and federal regulations; including the California Department of Alcohol and Beverage Control's regulations and City issued Administrative or Conditional Use Permit(s) conditions. In the event of a conflict between the requirements and/or conditions of this permit and any other permit, license, and regulation, the more stringent shall apply.

The operation of the primary business as a Banquet Hall Rental (banquet/event facility) as well as the Permittee shall comply with the Administrative Use Permit (App. No. 2203-20 [AUP22-007]) and appurtenant conditions issued by the Zoning Administrator (Attachment I).

- 5) Due to the proximity of neighboring businesses and residences, all door(s) and windows shall be kept closed at all times during any entertainment, except in cases

of emergency and to permit deliveries. Said door(s) is not to consist solely of a screen or ventilated security door. Sound shall not be audible beyond fifty feet (50') from the exterior of the premises in any direction.

- 6) Prohibition on Night Club Operations: The permittee is prohibited from utilizing the Banquet Hall Rental, or any portion thereof, as a Nightclub as defined by Long Beach Municipal Code 21.15.1855.
- 7) The permittee is required to actively monitor all exterior spaces of the Premises during events to prevent and stop any nuisance activity, including but not limited to excessive noise, illegal parking by event attendees, obstruction of the sidewalk, loitering and littering from disturbing the flow of traffic and surrounding neighbors. This shall be done by utilizing security guards and/or employees.
- 8) The permittee shall not allow employees to discard trash and/or glass bottles into the outside dumpster between 10 P.M. and 7:00 A.M.
- 9) The permittee shall be responsible for maintaining the Premises free of litter and the area adjacent to the Premises over which they have access.
- 10) The permittee shall install and maintain a video surveillance system that monitors no less than the front and rear of the business, with full view of the public rights-of-way and any parking lot under the control of the permittee. The video system must be capable of delineating on playback the activity and physical features of persons and areas within the premises. Recordings shall be retained for a minimum of thirty (30) calendar days and be accessible via the Internet by the Long Beach Police Department. A Public Internet Protocol (IP) address and username/password is also required to allow the Long Beach Police Department to view live and recorded video from these cameras over the Internet. All video security cameras shall be installed to the satisfaction of the Chief of Police, Director of Technology Services and Director of Development Services. The permittee may be required to add additional video cameras at the discretion of the Chief of Police.
- 11) The permittee must provide all individuals and entities who rent the Premises as a Banquet Hall Rental with a copy of the approved entertainment permit, which shall include a copy of all approved and applicable conditions of operation, including the Police Department Conditions and the AUP.

The permittee shall develop and maintain a plan to address neighborhood concerns, related to the operation of Bite Catering Couture dba Bite Catering Couture (i.e., newsletter, meetings, etc.).

- 12) The Entertainment Permit is subject to administrative review every two years from the date the permit is issued. If grounds exist for modification, revocation, or suspension of the permit, a hearing will be held.

II. **OPERATIONAL HOURS**

- 1) Indoor entertainment Activities shall be restricted to:
- A. Sunday through Thursday 8:00 AM to 11:00 PM.
 - B. Friday and Saturday 8:00 AM to 1:00 AM.
 - C. Up to six (6) times a year, hours may be extended with administrative approval at the discretion of the Zoning Administrator, per the AUP.
- 2) Outdoor entertainment activities at the Premises shall comply with the conditions of the AUP.
