

RESOLUTION NO. RES-24-0041

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH DECLARING THE RESULTS OF THE PRIMARY NOMINATING ELECTION HELD IN THE CITY OF LONG BEACH, CALIFORNIA, ON TUESDAY, MARCH 5, 2024 FOR THE PURPOSE OF NOMINATING AND/OR ELECTING CANDIDATES FOR THE FOLLOWING FOUR (4) OFFICES ON THE CITY COUNCIL FROM COUNCIL DISTRICT NUMBERS 2, 4, 6, AND 8; NOMINATING AND/OR ELECTING CANDIDATES FOR ONE (1) LONG BEACH UNIFIED SCHOOL DISTRICT GOVERNING BOARD OF EDUCATION OFFICE, DISTRICT NUMBER 2 ; AND DIRECTING THE CITY CLERK TO PLACE ON THE BALLOTS TO BE USED AT THE GENERAL MUNICIPAL ELECTION TO BE HELD ON NOVEMBER 5, 2024, THE NAMES OF THE CANDIDATES DECLARED TO HAVE BEEN NOMINATED IN THE PRIMARY NOMINATING ELECTION; AND DIRECTING THE CITY CLERK TO ISSUE A CERTIFICATE OF ELECTION TO THE CANDIDATES DECLARED TO HAVE BEEN ELECTED AT THE PRIMARY NOMINATING ELECTION

WHEREAS, the City Council of the City of Long Beach did, by Resolution No. RES-23-0155, duly call and provide for the holding of a Primary Nominating Election on Tuesday, March 5, 2024, for the purpose of nominating and/or electing candidates for the following four (4) City Council Offices, namely for the Second, Fourth, Sixth, and Eighth Districts; and, one (1) Long Beach Unified School District Governing Board Member,

District 2 ; and

WHEREAS, the election was held in the City of Long Beach on that day; and

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk, duly canvassed the returns of the election and has transmitted the results to the City Clerk;

NOW, THEREFORE, the City Council of the City of Long Beach does resolve, determine, order and declare as follows:

Section 1. That the Primary Nominating Election for the purpose of nominating and/or electing candidates as required by law for the following City Offices: four (4) Members of the City Council and; one (1) Long Beach Unified School District Governing Board Member, was duly held on Tuesday, March 5, 2024, and the votes cast, including the Vote by Mail ballots issued in connection with the election which were returned at the time and in the form and manner required by law were all duly and regularly canvassed. That the Los Angeles County Registrar-Recorder/County Clerk has duly canvassed the returns of the election and filed the Certificate of Canvass with the City Council and from that certification the City Council finds that the total number of votes cast in each district, the total number of votes cast in each of the respective election precincts established for the election, the number of votes cast for each candidate in each precinct and the total number of votes for each candidate, are as provided in Exhibit "A", attached hereto and made a part of this resolution.

Section 2. That the candidates nominated as required by law for the office of Member of the City Council from the Second District, and the names of the persons voted for at the election, were:

16 office of the Governing Board Member of the Long Beach Unified School District from the
17 Second District, and the names of the persons voted for at the election, were:

20 Section 7. That Cindy Allen received a majority of the votes cast of all
21 candidates for the office of Member of the City Council, Second District, and in accordance
22 with the provision of law governing the nomination and/or election of candidates for this
23 office, Cindy Allen is declared elected to the office of Member of the City Council, Second
24 District for the full term of four (4) years commencing with the third Tuesday of December,
25 2024. The City Clerk is directed to issue to Cindy Allen a Certificate of Election certifying
26 to the election to this office for such term.

27 Section 8. That the following are declared nominated for the office of the
28 Member of the City Council from the Fourth District:

2 Herlinda Chico

3 They are nominated for the office of Member of the City Council from the
4 Fourth District for the full term of four (4) years commencing on the third Tuesday of
5 December, 2024, and the City Clerk is directed to place their respective names on the
6 ballots to be used at the General Municipal Election to be held on the 5th day of November,
7 2024.

8 Section 9. That Suely Saro received a majority of the votes cast of all
9 candidates for the office of Member of the City Council, Sixth District, and in accordance
10 with the provision of law governing the nomination and/or election of candidates for this
11 office, Suely Saro is declared elected to the office of Member of the City Council, Sixth
12 District for the full term of four (4) years commencing with the third Tuesday of December,
13 2024. The City Clerk is directed to issue to Suely Saro a Certificate of Election certifying
14 to the election to this office for such term.

15 Section 10. That Tunua Thrash-Ntuk received a majority of the votes cast
16 of all candidates for the office of Member of the City Council, Eighth District, and in
17 accordance with the provision of law governing the nomination and/or election of
18 candidates for this office, Tunua Thrash-Ntuk is declared elected to the office of Member
19 of the City Council, Eighth District for the full term of four (4) years commencing with the
20 third Tuesday of December, 2024. The City Clerk is directed to issue to Tunua Thrash-
21 Ntuk a Certificate of Election certifying to the election to this office for such term.

22 Section 11. That Erik Miller received a majority of the votes cast of
23 all candidates for the Long Beach Unified School District Governing Board Member, District
24 2, and in accordance with the provision of law governing the nomination and/or election of
25 candidates for this office, Erik Miller is declared elected to the office of Long Beach Unified
26 School District Governing Board Member, District 2 for the full term of four (4) years
27 commencing with the third Tuesday of December, 2024. .

28 Section 12. This resolution shall take effect immediately upon its adoption

1 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
