A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING RESOLUTION NO. RES-22-0150 AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE A CONTRACT WITH QUALITY OFFICE FURNISHINGS, INC., FOR FURNITURE AND RELATED ACCESSORIES, ON THE SAME TERMS AND CONDITIONS AFFORDED TO THE REGION 4 EDUCATION SERVICE CENTER THROUGH THEIR CONTRACT WITH THE HON COMPANY LLC, AND THE REGENTS OF THE UNIVERSITY OF CALIFORNIA THROUGH THEIR CONTRACT WITH KIMBALL OFFICE, INC., BOTH MADE AVAILABLE AS A COOPERATIVE PURCHASING CONTRACT THROUGH OMNIA PARTNERS PUBLIC SECTOR

WHEREAS, on August 23, 2022, the City Council of the City of Long Beach adopted Resolution No. RES-22-0150, authorizing the City Manager or his designee to enter an agreement with Quality Office Furnishings, Inc. for furniture and related accessories and services in an amount of One Hundred Five Thousand Five Hundred Thirty-Five Dollars (\$105,535), with a fifteen percent (15%) contingency in the amount of Fifteen Thousand Eight Hundred Thirty Dollars (\$15,830), for a total contract amount not to exceed One Hundred Twenty-One Thousand Three Hundred Sixty-Five Dollars (\$121,365), until Region 4 Education Service Center Contract No. R191804 expires on April 30, 2023, and The Regents of the University of California on behalf of the University of California Contract No. 2019.001896 expires on April 30, 2024 with the option to renew for as long as the Contracts are in effect, at the discretion of the City Manager; and

1 WHEREAS, Contract No. R191804 was extended to April 30, 2025; and  
2 WHEREAS, Contract No. 2019.001896 was extended to May 30, 2027; and  
3 WHEREAS, on April 9, 2024, Agreement No. 36361 was amended to extend  
4 the term in accordance with the terms of Contract Nos. R191804 and 2019.001896; and

5 WHEREAS, in order to purchase furniture and fixtures for personnel returning  
6 to the historic Airport terminal, and for replacement of existing furniture/fixtures that are  
7 beyond repair or useful life, the contract authority of Agreement No. 36361 needs to be  
8 increased;

9 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
10 follows:

11 Section 1. The City Manager or designee is hereby authorized to amend  
12 Agreement No. 36361 to increase the not to exceed amount by Two Hundred Thousand  
13 Dollars (\$200,000) for a total not to exceed amount of Three Hundred Twenty-One  
14 Thousand Three Hundred Sixty-Five Dollars (\$321,365), for the period ending April 30,  
15 2025; thereafter, in an annual amount not to exceed One Hundred Thousand Dollars  
16 (\$100,000), for as long as Region 4 Education Service Center Contract No. R191804 and  
17 the Regents of the University of California on behalf of the University of California Contract  
18 No. 2019.001896 are in effect, at the discretion of the City Manager.

19 Section 2. This resolution shall take effect immediately upon its adoption  
20 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
