# *INTRODUCTION*

The Clean Team is an interdepartmental effort to beautify the community and enhance the quality of life of our citizens by removing litter and debris in public rights-of-way.

The Clean Team is responsible for addressing a wide range of tasks including the removal of dumped mattresses, cleaning alleys and parkways of trash and debris, addressing homeless encampments, graffiti removal, and managing various other sanitation issues.

Our crew consists of 15 Maintenance Assistants, and we contract with CCLB (Conservation Corps of Long Beach) to provide us with an additional 12 crew members.

PEH is a commonly used acronym which stands for Persons Experiencing Homelessness.

# *PROTOCOLS*

The Clean Team removes all homeless encampments on parkways, medians, alleys, and designated public right of ways.

We cannot remove any homeless encampments on private property, in the LA River, parks and beaches.

It is mandatory that we post a 48-hour notice to PEH to inform them to gather their belongings and vacate the premises. At which point, anything left behind will be disposed of.

We do not store any personal belongings unless the individual(s) were arrested at the time of the Clean Up.

We post every Monday and Friday and do Clean Ups Monday through Thursday. This can be modified on an approved basis by the Superintendent.

## *LOCATIONS SELECTED*

The Clean Team responds to reports of PEH from residents, property managers/owners, LAPD, Council staff, and interdepartmental staff. Reports of encampment locations are logged and posted on the next posting day.
