Subject: CD7 Fund Transfers in Support of Community Events

RECOMMENDATION

Recommendation to increase appropriations in the General Fund Group in the City Manager Department by \$2,000, offset by the Seventh Council District One-Time District Priority Funds, transferred from the Citywide Activities Department, to provide support for the following:

1. \$1,000 to Partners of Parks in support of the Long Beach Juneteenth Celebration; and,
2. \$1,000 to Conservation Corps of Long Beach (CCLB) in support of Dine on Pine 2024.

Decrease appropriations in the General Fund Group in the Citywide Activities Department by \$2,000 to offset transfers to the City Manager Department.

DISCUSSION

Through the above contributions, Councilmember Roberto Uranga seeks to support the missions and goals of the following organizations:

1. **Partners of Parks' Juneteenth Celebration:** Juneteenth is the oldest nationally celebrated commemoration of the ending of slavery in the United States. Held annually, the Juneteenth celebration attracts 15,000 guests to Long Beach's Rainbow Lagoon for a day of celebration, education, food, & entertainment.
2. **CCLB's Dine on Pine:** The CCLB provides workforce development, educational opportunities and work projects that support Long Beach youth. CCLB is instrumental in maintaining our city parks and keeping our streets clean. Dine on Pine supports CCLB's mission.

This matter has been reviewed by Budget Analyst Joe R. Guerrero on June 3, 2024.

FISCAL IMPACT

This recommendation requests the City Manager to provide contributions of \$1,000 to Partners of Parks and \$1,000 to Conservation Corps of Long Beach. The total appropriation increase of \$2,000 in the General Fund Group in the City Manager Department will be offset by a decrease

of appropriation of Seventh Council District One-time District Priority Funds in the General Fund Group in the Citywide Activities Department. The requested action is anticipated to require a minimal level of staff hours beyond the normal budgeted scope of duties and expected to have minimal impact on existing City Council priorities.

LEVINE ACT

This item is subject to the Levine Act. City elected and appointed officials, including candidates for City elected office (City Officers), who have received a contribution of more than \$250 within 12 months prior from a party, participant, or their representatives involved in this proceeding may do either of the following: (1) disclose the contribution on the record and recuse themselves from this proceeding; OR (2) return the portion of the contribution that exceeds \$250 within 30 days from the time the elected official knew or should have known about the contribution and participate in the proceeding.

All parties, participants, and their representatives must disclose on the record of this proceeding any contribution of more than \$250 made to the City Officers, such as the Mayor and/or Councilmembers, within 12 months prior to the date of the proceeding. City Officers are prohibited from accepting, soliciting, or directing a contribution of more than \$250 from a party, participant, or their representatives during a proceeding and for 12 months following the date a final decision is rendered.
