PETITION TO THE CITY OF LONG BEACH

OPPOSITION TO PROPOSED SIDEWALKS ON E CURRY STREET, LONG BEACH, 90805

We the undersigned, hereby petition to City of Long Beach, California to abandon a proposed construction project for addition of sidewalks to East Curry Street. This will be a nuisance to all businesses being ran on E Curry Street. E Curry Street is completely an Industrial work zone with Semi trucks and deliveries happening daily, beginning around 4am and into the late evening, including some weekends. Our current Arguments are as follows:

1. This is an industrial street. We have semi's going up and down the street throughout the day. There are 2 different companies that pull underground cable and street maintenance work hauling wood, cement and asphalt on a daily basis. There are 2 car haulers that ship cars on semi's daily on this street. We have 3 different pot growing companies (do not sell to public). There is a fabrication shop that is 98% email only orders and deals mainly with Aerospace clients. There is a steel company that takes in shipments daily from semis of unloading, loading and also providing service with their own trucking company on deliveries. We now have a fleet of semis across the street who load at the harbor with 40' containers and then bring them here to be unloaded into a warehouse. The 10 semis have NO parking in the lot that they rent and park in the current parking spots on the street, backed up to the fence. There will be no parking for them if sidewalks go in. There will be no parking for anyone's employees for any of the businesses on this street if sidewalks go in. Since it is illegal to park on a sidewalk, there will be no parking on our street that works for the companies that are doing business. Currently the parking is scarce without sidewalks and some people park on Cherry Ave. If sidewalks were to be put in place, there will be no parking for any of the businesses and everyone will be forced to park on Cherry Ave. Putting in sidewalks would have a severe impact to all businesses on this street.
2. The safest route for the residences that live on E Poppy Street and E Harding Street are up their own streets to Cherry Ave or each others' streets to Cherry Ave. There is no reason to come from those streets down E Curry Street. There is full access and sidewalks on Cherry Ave for travel from both E Harding Street and E Poppy Street that are safe for travel. There is nothing in the works to even connect E Poppy Street to E Harding Street to E Curry Street. There is absolutely no purpose E Curry Street serves as an in and out path for E Harding and E Poppy Streets. Best access is to/from Cherry Ave providing a straight access point for each street to safely travel.
3. Can the City of Long Beach instead place signs on Terminal Street at the entrance of E Curry Street and at the entrance of E Curry Street on Cherry Ave that state:
"INDUSTRIAL AREA – NO PEDESTRIAN TRAFFIC BEYOND THIS POINT"
I have seen signs like this before, so why not now? This is not a street for pedestrian travel or children.


Hi Susiy-
