**RECOMMENDATION:**

Recommendation to authorize the City Manager, or designee, to execute all documents necessary to amend Contract No. 35815 with Galls LLC, of Cerritos, CA, for furnishing and delivering police uniforms and accessories, to extend the term of the contract to February 28, 2025, with the option to renew for as long as the City of Los Angeles contract is in effect. (Citywide)

**DISCUSSION**

City Council approval is requested to amend Contract No. 35815 with Galls, LLC (Galls) to continue supplying police uniforms and accessories. The amendment will extend the term to February 28, 2025, with the option to renew for as long as the City of Los Angeles contract is in effect. It is anticipated that the City of Los Angeles will continue to extend their agreement with Galls on a quarterly basis.

At its meeting on December 15, 2020, the City Council awarded a contract to Galls as part of its adoption of Resolution No. RES-20-0168 for police uniforms and accessories for a period of one year, with the option to renew for three additional one-year periods.

This amendment will enable the City to continue to leverage competitive pricing through the City of Los Angeles contract, resulting in cost savings and more effective use of public funds. Additionally, this agreement provides access to high-quality police uniforms and accessories, specifically designed to meet the unique operational and professional standards of the Long Beach Police Department. Approval of this amendment is essential to maintain uninterrupted access to critical resources, supporting the professional appearance, safety, and operational readiness of law enforcement personnel, and ultimately contributing to the effective delivery of public safety services to the community.

This matter was reviewed by Administrative Analyst Tommy Ryan on January 15, 2025, Deputy City Attorney Eliezer Ben-Shmuel on January 23, 2025, and by Budget Management Officer Nader Kaamoush on January 27, 2025.

**TIMING CONSIDERATIONS**

City Council action to amend Contract No. 35815 is requested on February 11, 2025, to ensure there is no interruption to services.

FISCAL IMPACT

The requested action extends the contract term with Galls LLC to February 28, 2025, with the option to renew for as long as the City of Los Angeles contract is in effect. There is no change to the annual contract authority; this request only pertains to the contract term. The total annual contract amount will remain in an amount not to exceed \$500,000. Sufficient appropriation is budgeted in the amount of \$470,000 in the General Fund Group, \$18,000 in the Tidelands Operating Fund Group, and \$12,000 in the Tidelands Area Fund Group in the Police Department. This recommendation has no staffing impact beyond the normal budgeted scope of duties and is consistent with existing City Council priorities. There is no local job impact associated with this recommendation.
