COMMISSION PURPOSE

The purpose of the Climate Resilient & Sustainable City Commission (Commission) is to make advisory policy recommendations to the City Council on issues relating to the environment; a sustainable city plan; efforts or programs to address environmental issues such as air quality, water quality, and resource conservation relating to the protection and integrity of the natural environment; programs to increase education and awareness of the environment; to serve as a forum for community discussion of these environmental issues; and to encourage input and participation from all sectors of the community on issues of sustainability and the environment.

OVERVIEW

The Commission was created by the City Council as an advisory body in 2008 and was originally named the Sustainable City Commission. After the Long Beach Climate Action Plan (LB CAP) was adopted in 2022, the Commission was tasked with overseeing and supporting staff's implementation of the policy document. In 2023, the Commission name was revised to the Climate Resilient and Sustainable City Commission to reflect its expanded role.

The Commission had seven meetings scheduled in 2024. The June meeting was cancelled due to a lack of quorum. The officer elections were moved from June to the August meeting. In January, the Commission confirmed the 2024 meeting structure that aligns with the sectors of the LB CAP, which is as follows:

The Commission looks forward to working with the City and its representatives over the coming years and hopes to continue actively engaging the public through outreach efforts relating to the Office's work plan.

COMMISSIONERS & ATTENDANCE

The Commission is comprised of eleven members, one to represent each of the nine council districts and two members appointed at-large. Commissioners are appointed by the Mayor and confirmed by the City Council. The Chair and Vice Chair were elected in August and will serve a one-year term. There was a meeting that was cancelled on June 27, 2024, due to lack of quorum. The 2024 attendance for the Commission is as follows:

Expenses

Support for the Commission's work is included in the Office of Climate Action and Sustainability budget within the City Manager's Department. Payments to Commissioners were budgeted for \$4,400; however, several of the commissioners declined payments and served as volunteers. Additional costs covered by the Office of Climate Action & Sustainability fund for Commission support are typically limited to expenses for refreshments. In 2024, these expenses totaled \$91.69.

To support the Commission, a core team of eight staff from the Office of Climate Action & Sustainability, Office of the City Clerk, and Office of the City Attorney provide support functions, including agenda development, commission coordination, presentation development and speaker coordination, and facilitation of recommendations to City Council. Additionally, staff from several other departments dedicate substantial time for each meeting to prepare and present information on relevant topics.

Recommendations

Staff recommend that the Climate Resilient & Sustainable City Commission continue as established by Ordinance No. ORD-07-0024. There are two issues to note that affect the Commission's ability to successfully conduct business:

- 1.) Commissioner Makeup: The Commission has 11 members - 9 appointed by Council District and two at-large members. The Commission has not had all 11 positions appointed and this number of Commissioners does not physically fit in the number of seats available on the City Council dais, which is the location for Commission meetings.
- 2.) Commission Vacancies: The Commission continues to have vacancies that impact the ability to retain a consistent quorum for meetings. One meeting was cancelled due to lack of quorum. At such time there are vacancies, it will be important to quickly fill those vacancies to ensure quorum can be maintained.
