Subject: **Draft 2025 Legislative Agenda**

Each year, City staff reviews the State and Federal Legislative Agendas and recommends changes to reflect the City's legislative and funding priorities for the upcoming year.

In October 2024, the Government Affairs Office hosted a training session for all departments to be informed on the 2025 Legislative Agenda (Agenda) update process and timeline. The Government Affairs Office then circulated the draft 2025 Legislative Agenda to departments for input on potential changes. Following departmental review, the Government Affairs team met with departments individually to further refine their recommended legislative and funding priorities for the upcoming year. This memorandum presents staff recommendations that have been incorporated into the attached 2025 Draft Legislative Agenda for the Intergovernmental Affairs Committee's consideration.

In addition to the revisions made in collaboration with City Departments, the draft Agenda remains aligned with the 2030 Strategic Vision, incorporating language added last year in the Focus Statements Section to highlight the priorities established in the Vision. The infrastructure section continues to be framed around the Elevate '28 Infrastructure Investment Plan to support additional funding for critical infrastructure needs and projects in preparation for the 2028 Olympic and Paralympic Games. Lastly, the attached draft Agenda streamlines language to eliminate duplication across state and federal priorities.

Proposed Changes to the Legislative Agenda

Changes in the attached draft Agenda are denoted as follows:

- New and/or revised proposed language is indicated by underline blue font.
- Staff recommendations to delete duplicative or obsolete items are indicated by ~~red and strikethrough~~ text.

The following section outlines the proposed changes in the attached draft Agenda, organized by their respective categories, along with a brief explanation of the rationale behind each change. For a complete review of the Agenda and the proposed changes, please refer to the attached document.

2024 FOCUS STATEMENTS

Infrastructure

- “Support resilient drainage and flood control infrastructure.”

Rationale: Added by the Public Works Department to be consistent with stormwater sections.

- “Support the construction of and improvements to vital public safety infrastructure such as fire and police stations, health facilities, radio infrastructure, technology infrastructure, interagency data-sharing, and emergency preparation and response resources.”

Rationale: Added by Fire Department. Underlined text added to include technological aspects of public safety infrastructure.

- “Support for emergency medical services to be equitably delivered to visitors and residents and mitigate service delays or reduction to 911 ambulance service in preparation and during the 2028 Olympic and Paralympic Games.”

Rationale: Added by Fire Department. The City needs a plan to ensure 911 ambulance and emergency health services can sufficiently support the increased population in the City due to visitors/athletes participating in the games. Servicing the enhanced population should not create reduced service to the rest of the City's residents.

Recovery

- “Support policies, resources, and programs that reduce the ambulance patient offload delays between the City’s 911 emergency health ambulance units and regional hospitals.”

Rationale: Added by the Fire Department. This supports new legislation adopted to hold hospitals accountable to staff Emergency Rooms appropriately.

EDUCATION

2.1 Education Equity

- “Support policies, legislation, and grants that seek to end the school-to-prison pipeline and reduce school expulsions/suspensions and chronic absenteeism “

Rationale: Added by the Health and Human Services Department. In terms of educational equity, this is a core element to reducing school pushout which leads

to the school to prison pipeline.

- “Support policies, legislation, and grants to bolster strategies to actively engage youth who are Opportunity Youth (out-of-school and out-of-work), disconnected, emancipated, gang impacted, and have had significant involvement with the justice system.”

Rationale: Revised by the Health and Human Services Department. Added the underlined language, "Opportunity Youth (out of school and out of work), Gang Impacted, Foster youth".

- “Support policies, legislation and grants that uplift boys and young men of color as aligned with the My Brother’s Keeper six milestones”

Rationale: Added by the Health and Human Services Department. Long Beach is recertifying as an My Brother’s Keeper City; adding this supports educational equity considering the data that reflects young men of color as having some of the lowest educational attainment rates.

ENERGY

3.2 Utilities and Waste Management

- “Support policies, legislation or grants that assist the City’s efforts to meet the procurement requirements established in SB1383.”

Rationale: Added by the Public Works Department. Like most cities in CA, Long Beach is not meeting the procurement requirements of SB1383 which require cities to purchase RNG from organic waste, bioelectricity, compost, or mulch from SB1383 certified facilities based on population. The market for the material needed does not currently exist locally.

- “Support policies, legislation and funding that assist the City’s effort to build an anaerobic digestion facility in place of the Southeast Resource Recovery Facility (SERRF), including efforts to foster innovative partnerships that will promote sustainability, recycling and beneficial reuse of municipal solid waste.”

Rationale: Revised by the Public Works Department. Underlined text added as SERRF is now closed, and the RFP is complete for a new AD facility to be built in its place. The City should switch from supporting legislation and funding for waste to energy facilities to support the funding of this new facility and other solutions for the City’s waste reduction efforts and solid waste management.

- “Support policies and legislation to require cap and trade regulations to give credit for greenhouse gas emission reductions that are attributable to anaerobic digestion

facilities, (community) compost facilities, waste to energy facilities and the Port of Long Beach's Clean Air Action Plan."

Rationale: Revised by the Public Works Department. Underlined text added to switch from the closed SERRF facility to the new type of waste facility planned to be built in its place.

- "Support increased funding over current savings levels for the subsidence fund to manage elevations after the oil fields cease to produce."

Rationale: Added by the Energy Resource Department. The subsidence fund was set up in 1964 and funding ceased in 1984. Additional funds are needed to ensure sufficient funding for this effort; otherwise it will fall to the City to fund.

- DELETED: "Support expedited funding over current savings levels for the State's future obligations for the abandonment and cleanup of the oil field located in the Wilmington Oil Field."

Rationale: Deleted by the Energy Resources Department. SB 1425 eliminates the need for this support.

- DELETED: "Support policy changes that encourage diversity in waste treatment options and recognize waste to energy technologies as a sustainable means of waste disposable and energy production."

Rationale: Deleted by the Public Works Department. This may be deleted because SERRF no longer is operational.

- "Support policies, legislation, and funding that support waste minimization, reuse policies, and extended producer responsibility policies."

Rationale: Added by the Public Works Department. Added a more general statement to support current waste reduction and EPR efforts.

ENVIRONMENT, NATURAL RESOURCES AND RECREATION

4.1 Air Quality and Environmental Sustainability

- DELETED: "Support policies, legislation, and grants that protect the city's ability to efficiently operate the Southeast Resource Recovery Facility (SERRF) in a cost-effective manner."

Rationale: Deleted by the Public Works Department. Removing because SERRF is closed.

4.2 Long Beach Climate Action Plan (LB CAP)

- “Oppose policies and legislation that reduce funding for climate change initiatives.”

Rationale: Added by the City Manager’s Department. In addition to supporting policies and legislation that increase funding, we should oppose policies and legislation that decrease funding. This is especially important at the federal level where the incoming administration may reverse existing climate initiatives or limit our ability to work towards the City’s climate goals.

- “Oppose policies and legislation that would limit the City’s ability to implement the Long Beach Climate Action Plan or take other measures to reduce greenhouse gas emissions and adapt to climate change impacts.”

Rationale: Added by the City Manager’s Department. We should oppose policies and legislation that limit the City’s ability to implement the LB CAP in anticipation of climate and environmental sustainability changes at the federal level. This could be anything from building code regulations and incentives for clean/renewable energy to limiting emissions near ports.

4.3 Stormwater Management and Recreational Water Quality

- “Support policies, legislation and funding that would provide local governments with resources to implement stormwater management best practices, including low impact development (LID), green infrastructure approaches, and nature based solutions to capture and reduce pollution in stormwater at its source, maintain municipal separate storm sewer systems (MS4) permit compliance, complete drainage infrastructure improvements and other initiatives to improve recreational water quality at the City’s beaches and local waterways.”

Rationale: Revised by Public Works to align with additional bullet points in the Stormwater Management and Recreational Water Quality section.

- “Support policies, legislation, and grants for the assessment and reduction of pollutants in water that may effect recreational water quality at the City’s beaches, including funding for innovate stormwater capture, filtration and other stormwater best management practices in the Los Angeles River, San Gabriel River, Los Cerritos Channel, Dominguez Channel, and nearshore watersheds.

Rationale: Revised by Public Works Department to add Los Cerritos Channel, Dominguez Channel and nearshore waterways.

- DELETED: Oppose any policy or legislation that would reclassify areas currently protected by recently upgraded, federally certified flood protection levees with no demonstrable history of flooding as “residual risk” zones that would be subject to

mandatory flood insurance. In such areas locally, require FEMA to meet current requirements for a formal flood insurance study before attempting a rezone as a flood risk area.

Rationale: Deleted by Public Works Department and replaced with the following two bullet points to ensure data driven decisions are used to protect vulnerable communities.

- “Encourage continued development of a risk-based flood insurance program that is fair, equitable and utilizes sound engineering and scientific data in establishment of flood zones and insurance rates.”

Rationale: Added by the Public Works Department. Added in to support data-driven decisions in protecting vulnerable communities.

- “Support sustainable management of flood risks to reduce loss of life, economic damage to housing and commercial buildings and infrastructure, and improve the natural environment.”

Rationale: Added by the Public Works Department. Added to support data-driven decisions in protecting vulnerable communities.

FISCAL RESPONSIBILITY

Revenue, Fees, and Taxation

- “Oppose legislation that limits the City’s ability to get fully reimbursed by FEMA/CalOES for emergency funding during the COVID-19 pandemic.”

Rationale: Added by the Financial Management Department to support the City’s pending reimbursements from FEMA for the costs during the COVID 19 pandemic.

GENERAL GOVERNMENT

6.3 Land Use Planning

- “Support policies which embrace equitable, inclusive, and anti-racist planning, programs, and practices that acknowledge past harms and address current inequities.”

Rationale: Added by the Community Development Department in alignment with the City’s Racial Equity and Reconciliation Initiative Goals 1 and 4.

- “Support policies that encourage new investment and development in under-resourced and disadvantaged communities. Such policies should incorporate

strategies for capacity building of impacted populations, preserve cultural assets, and expand minority business ownership.”

Rationale: Added by the Community Development Department in alignment with the City’s Racial Equity and Reconciliation Initiative Goals 1 and 4.

- “Support policies and increased funding to maintain or replace outdated or failing infrastructure, amenities, and services in under-resourced communities. This may include high-quality public transit, pedestrian, and bikeway systems, open space, tree canopy, recreational amenities, clean and safe drinking water, and other critical needs.”

Rationale: Added by the Community Development Department to support the LB Elevate 28 Infrastructure Plan to prioritize and fund critical infrastructure.

- “Support policies to conduct inclusive and meaningful public outreach and engagement throughout planning, development review, and implementation processes.”

Rationale: Added by the Community Development Department in alignment with the City’s Racial Equity and Reconciliation Initiative Goals 1 and 3.

- “Support state-funded financing to supplement impact fees to pay for infrastructure, community benefits and services to reduce housing development costs.”

Rationale: Added by the Community Development Department. ADU housing permits were the highest issued housing permit type in the City last year. The City is not allowed to charge impact fees for many ADU permits creating a burden on infrastructure and services. Support for legislation will provide a way for the City to recover costs.

- “Support state programs that encourage remediation and redevelopment of brownfield and gray field sites.”

Rationale: Added by the Community Development Department to support funding necessary to complete remediation efforts for development and redevelopment sites.

- “Support policies that strengthen regional planning and collaboration around issues at the regional or sub-regional level—such as affordable housing, air quality, greenhouse gas emissions mitigation, regional transportation, hazard mitigation and climate adaptation, and water management and flood control.”

Rationale: Added by the Community Development Department. Regional

partnerships are needed to progress on existing land issues.

- “Support policies that encourage or incentivize development in high resource areas such as mixed income housing incentives for development in TCAC High Opportunity areas.”

Rationale: Added by the Community Development Department. Resources and enforcement tools are needed to encourage development.

- “Support policies that encourage streamlined environmental review, clarifying CEQA applicability as it relates to housing production and local land use decision making.”

Rationale: Added by the Community Development Department. Correctly navigating the CEQA process is essential for local planning.

- “Amend CEQA to exempt priority housing projects which are consistent with local plans, including Housing Element programs and RHNA obligations.”

Rationale: Added by the Community Development Department. CEQA requirements are at odds with our state mandated housing obligations.

- “Amend CEQA to provide exemptions for all projects with 100% affordable residential units.”

Rationale: Added by the Community Development Department. Correctly navigating the CEQA process is one of the most complicated aspects of local planning with innumerable challenges stemming from poorly worded, contradictory, or inconsistently enforced state law. Many CEQA requirements are at odds with our state mandated housing obligations. We need the state to engage in CEQA reform.

- “Amend CEQA to provide more robust exemptions for infill projects.”

Rationale: Added by the Community Development Department. Correctly navigating the CEQA process is one of the most complicated aspects of local planning with innumerable challenges stemming from poorly worded, contradictory, or inconsistently enforced state law. Many CEQA requirements are at odds with our state mandated housing obligations. We need the state to engage in CEQA reform.

- “Amend CEQA to maximize the use of tiering to encourage up-front review of environmental impacts to limit or avoid project-by-project CEQA review.”

Rationale: Added by the Community Development Department. Correctly

navigating the CEQA process is one of the most complicated aspects of local planning with innumerable challenges stemming from poorly worded, contradictory, or inconsistently enforced state law. Many CEQA requirements are at odds with our state mandated housing obligations. We need the state to engage in CEQA reform.

- “Amend CEQA to exempt certain infrastructure projects that further goals for greenhouse gas reduction (i.e. battery storage uses that capture green electricity).”

Rationale: Added by the Community Development Department. Correctly navigating the CEQA process is one of the most complicated aspects of local planning with innumerable challenges stemming from poorly worded, contradictory, or inconsistently enforced state law. Many CEQA requirements are at odds with our state mandated housing obligations. We need the state to engage in CEQA reform.

- “Amend CEQA to exempt emergency shelters and supportive/transitional housing.”

Rationale: Added by the Community Development Department. Correctly navigating the CEQA process is one of the most complicated aspects of local planning with innumerable challenges stemming from poorly worded, contradictory, or inconsistently enforced state law. Many CEQA requirements are at odds with our state mandated housing obligations. We need the state to engage in CEQA reform.

6.4 Local Initiatives

- Support policies, legislation, and grants for the implementation of the Long Beach Violence Prevention Plan, My Brother’s Keeper Local Action Plan, and the Youth & Emerging Adults Strategic Plan.

Rationale: Added by the Health and Human Services Department. Expand the support for youth programming and add in the Youth & Emerging Adults Strategic Plan.

6.8 Equity

- “Support policies, legislation, and funding that allocates resources to non-profit organizations, community-based organizations and trusted partners that serve the LGBTQIA2S+ community, specifically transgender, gender non-conforming and intersex individuals.”

Rationale: Added by the Health and Human Services Department to support community-based organizations that serve LGBTQIA2S+ individuals to further

address health inequity and health disparities.

- “Support policies, legislation, and funding to maximize opportunities for racial equity through housing policies that address segregation and access to homeownership.”

Rationale: Added by the Health and Human Services Department to support funding and legislation to increase opportunities for homeownership for historically disadvantaged individuals.

- “Support policies, legislation, and funding that aims to increase the recruitment and retention of Black, Latinx, Asian, Indigenous, other people of color and LGBTQIA2S+ individuals to employment and leadership positions.”

Rationale: Revised by the Health and Human Services Department. Underlined text added to support initiatives to increase diversity and representation in the workforce.

- “Oppose policies and legislation that restricts or penalizes medical professionals from providing gender-affirming healthcare for transgender and non-binary minors.”

Rationale: Added by the Health and Human Services Department to oppose penalizing gender-affirming healthcare for transgender and non-binary minors prevents medical professionals from assisting individuals in need.

- “Support policies and legislation that ban “reparative” or “conversion” therapy for LGBTQIA2S+ youth.”

Rationale: Added by the Health and Human Services Department to anticipate the impact of potential changes in healthcare with changes in federal political administration.

- “Support protection of the Deferred Action for Childhood Arrivals (DACA) program so recipients may continue having protected status from deportation, access to work, and healthcare.”

Rationale: Added by the Health and Human Services Department to anticipate the impact of potential changes in immigration law with change in federal political administration.

HOUSING

7.2 Homelessness

- “Support federal resources that focus on operational and administrative funding for homelessness planning the City. This includes advocating for operational and administrative funding to ensure the effective delivery of services and to support strategic planning and coordination efforts. This will enable the City to provide comprehensive support to individuals experiencing homelessness and proactively prevent homelessness.”

Rationale: Added by the City Manager’s Department. Support for funding resources dedicated to administrative planning for homelessness initiatives.

PUBLIC HEALTH

8.1 Intervention

- “Support policies, legislation, and grants that increase funding for the Long Beach Youth Fund, ensuring resources are allocated to youth development programs.”

Rationale: Added by the Health and Human Services Department. Support funding for more tailored youth programs that address the unique needs of Long Beach youth.

- “Support policies, legislation, and grants that support participatory budgeting initiatives that empower youth to design and decide on programs that best meet their needs and aspirations, foster a sense of ownership and leadership.”

Rationale: Added by the Health and Human Services Department. Support youth civic engagement and involvement in youth programs.

- “Support policies, legislation, and grants that support community benefits through nutrition assistance programs, increasing benefit amounts, that may help reduce food insecurity and hunger.”

Rationale: Added by the Health and Human Services Department. Support funding for nutrition security programs as Long Beach Recovery Act Program concludes.

- “Support policies, legislation, and grants that prioritize funding and investments in nutrition education, physical activity programs, and initiatives aimed at reducing the prevalence of obesity and diabetes, particularly among children and adolescents.”

Rationale: Added by the Health and Human Services Department. Support funding

resources for nutrition education and physical activity programs.

- “Support policies, legislation, and grants that support programs and initiatives focused on improving cardiovascular health in adults through interventions to lower blood pressure, cholesterol, and blood sugar, as well as expanding access to preventive care, and chronic disease management resources.”

Rationale: Added by the Health and Human Services Department. Support funding resources for cardiovascular health programs.

- “Support policies, legislation, and grants that support objectives to address substance use and substance use disorders, including but not limited to prescription drug misuse, opioid use, alcohol consumption, and reducing access to substances among adolescents.”

Rationale: Added by the Health and Human Services Department. Support funding resources for substance abuse prevention programs.

- “Support policies, legislation and funding for the quality, use, transparency and public availability of comprehensive disaggregated data to inform decisions and actions that improve quality of life outcomes for Black, Indigenous, Asian, Latinx, LGBTQIA2S+, immigrants, unhoused, and other communities of color.”

Rationale: Revised by the Health and Human Services Department. Underlined text added. The more we educate the public that does not currently understand queer lives, identities, or needs, the less pushback we may hope to experience.

- “Support policies, legislation, and funding aimed at public health education related to destigmatization of LGBTQIA2S+ healthcare, HIV infection status, sexual health, and reproductive services.”

Rationale: Added by the Health and Human Services Department. Support funding resources for public health education programs to demystify understanding of unique LGBTQIA2S+ individual needs.

- DELETED: “Support funding to implement the Safe Long Beach Violence Prevention Plan, which includes prevention, intervention, treatment and suppression.”

Rationale: Deleted by Health and Human Services Department. This program has concluded.

- “Support funding to implement the Long Beach Youth & Emerging Adults Strategic Plan, which includes youth development, health, workforce, violence prevention, housing, and transportation.”

Rationale: Added by the Health and Human Services Department. Support funding resources for Long Beach Youth and Emerging Adults Strategic Plan adopted by Long Beach City Council in 2021.

8.3 Cannabis and Tobacco Regulation

- ~~DELETED:~~ “Support policies and legislation that decrease the State cannabis cultivation tax in an effort to make the legal cannabis and tobacco use, including youth access and trends in vaping.”

Rationale: Deleted by the City Manager’s Department. The cultivation tax was reduced in 2022 as part of the budget act.

- “Support policies, legislation, and funding to enhance data collection and reporting on the health impacts of cannabis and tobacco use, including youth access and trends in vaping.”

Rationale: Added by the Health and Human Services Department. Access to improved data resources can help focus prevention and education efforts more effectively.

- “Support funding and programs for cannabis and tobacco cessation services, particularly in underserved communities.”

Rationale: Added by the Health and Human Services Department. Access to cessation services can address disparities in health outcomes related to cannabis and tobacco use.

- “Support policies, legislation, and grants to regulate and monitor the marketing of cannabis and tobacco products on social media and digital platforms to protect youth.”

Rationale: Added by the Health and Human Services Department. Regulation of cannabis and tobacco marketing targeted at our youth is critical for prevention.

- “Support policies and legislation to limit the potency of cannabis products and require clear, standardized labeling for cannabis and tobacco products.”

Rationale: Added by the Health and Human Services Department. Requiring clear labeling and potency limits helps consumers make informed decisions and reduce potential health risks.

PUBLIC SAFETY

9.2 Innovation

- DELETED: “Support federal policies that would be applicable nationwide to create a system that would enable medical cannabis to be distributed at accredited pharmacies.”

Rationale: Deleted by the City Manager’s Department. Contradictory with current state regulations that only allow cannabis to be sold at licensed dispensaries.

9.5 Partnerships

- “Support the funding and use of regional task forces to combat organized crime involving robbery, commercial burglary, human trafficking, sex trafficking, and motor vehicle theft.”

Rationale: Revised by the Police Department. Replacing “retail theft/smash and grabs” language for “motor vehicle theft”. CA has an organized retail theft prevention program and a retail crime task force.

- “Support legislation, policy and funding that supports gun safety education to securely store firearms.”

Rationale: Added by the Health and Human Services Department. Gun safety is important for public health and well-being.

9.6 Emergency Preparedness

- “Support policies, legislation and funding to implement or improve upon natural disaster early warning systems and early bio-detection programs.”

Rationale: Added by the Health and Human Services Department. Underlined text added to support including bio-detection programs and wastewater surveillance which are important tools in public health.

- “Support policies, legislation, regional initiatives and funding to strengthen equitable and inclusive community resilience strategies.”

- *Rationale: Added by the Health and Human Services Department. Community resilience strategies are important for program sustainability and recovery efforts. Communities with higher levels of community resilience are more likely to prepare for and respond to emergencies*

- “Support policies, legislation and grants to fully fund technologies that provide the

public with enhanced forecasting of natural disasters and report public safety emergency needs (e.g., text to 9-1-1).”

Rationale: Revised by the Health and Human Services Department. This revision represents the combination of multiple items for streamlining.

- DELETED: “Support policies, legislation, regional initiatives and funding to advance equitable and inclusive emergency response efforts for vulnerable populations.”

Rationale: Deleted by the Health and Human Services Department. This item was duplicative.

TECHNOLOGY

10.1 Digital Inclusion

- “Oppose funding cuts and eligibility changes to the Digital Equity Act grant programs.”

Rationale: Added by the Technology Innovation Department to support the City’s Digital Inclusion Initiative and ensure that everyone in Long Beach has equitable access and use of computer literacy training, the Internet, technology devices and other digital inclusion resources and services.

10.3 Cybersecurity

- “Support policies, legislation and funding that protect the public’s digital privacy rights, safeguard the security and control of access to personal data and technological systems, and secure the public’s trust in utilization of new and emerging technologies.”

Rationale: Added by the Technology and Innovation Department to safeguard the City’s technology and data from security breaches.

10.4 Artificial Intelligence (new proposed section)

- “Support policies, legislation, and funding that advance the development and use of artificial intelligence (AI) systems for social good, improvement of government services, and ethical, non-discriminatory, and responsible AI governance.”

Rationale: Added by the Technology and Innovation Department. Support use of Artificial Intelligence to be used to improve public service delivery while safeguarding core values of equity, transparency, ethics, and safety/security.

- “Support cooperative purchasing efforts for AI systems and tools among government agencies.”

Rationale: Added by the Technology and Innovation Department. Support use of Artificial Intelligence to be used to improve public service delivery while safeguarding core values of equity, transparency, ethics, and safety/security.

- “Support policies, legislation, and funding that promote workforce development and resilience through AI training and skill development.”

Rationale: Added by the Technology and Innovation Department. Support use of Artificial Intelligence to be used to improve economic opportunities while safeguarding core values of equity, transparency, ethics, and safety/security.

- “Support policies and legislation that promote AI system vendor accountability, reporting, and transparency.”

Rationale: Added by the Technology and Innovation Department. Support use of Artificial Intelligence to be used to improve public service delivery while safeguarding core values of equity, transparency, ethics, and safety/security.

TRANSPORTATION

11.1 Active Transportation and Transit-Oriented Development

- “Pursuing policies, legislation and grants to improve, beautify, maintain, and increase the safety of the I-710 Freeway, which serves as a vital thoroughfare for residents, businesses and commerce, including funding for I-710 Early Action Projects, beginning with the realignment of Shoreline Drive and the replacement of Shoemaker Bridge.”

Rationale: Revised by the Public Works Department. Underlined text added to reflect the alignment of Shoreline Drive and Shoemaker Bridge.

- “Support policies, legislation and funding to provide free transportation (such as Metro LIFE or Long Beach Transit GoPass) to youth for educational and recreational prosocial development activities.”

Rationale: Added by the Health and Human Services Department to ensure accessible public transportation for young people to participate in prosocial programming of positive youth development and youth violence prevention.

11.2 Roadway Safety

- “Support legislation, policies, and funding to establish and expand pilot programs

for automated traffic speed and vehicle noise enforcement in high-injury networks and specific locations near schools, senior zones, public parks, and recreation centers.”

Rationale: Revised by the Public Works Department. Underlined text added to include expansion of pilot programs for automated traffic speed and vehicle noise enforcement in high-injury networks and specific locations.

11.3 Safe Streets Long Beach (Vision Zero)

- “Support policies, legislation, and grants to update existing vehicle design standards to reduce roadway injuries and fatalities by considering pedestrian safety and the safety of other vehicles.”

Rationale: Added by the Public Works Department to support updates to both roadway and vehicle design standards.

- “Support policies and legislation to restore local control for design at intersections shared with Caltrans to expedite projects which improve safety and complete streets designs along its facilities.”

Rationale: Added by the Public Works Department to give City local control over design authority that is currently exerted by Caltrans for areas within hundreds of feet around intersections closest to interstate facilities and on roadways without on-ramps or off-ramps, resulting in areas without sidewalks, deficient bikeways, and high-speed conditions.

- “Support policies, legislation, and grants that fund public education campaigns and enforcement programs to reduce distracted and drug-impaired driving and improve roadway safety.”

Rationale: Added by the Health and Human Services Department to support funding resources for public education campaigns and enforcement programs to address distracted and drug impaired driving and improve overall roadway safety for all users.

Next Steps

An Intergovernmental Affairs Committee meeting will be scheduled in the near future to review and discuss staff’s recommendations for the 2025 Legislative Agenda. Upon approval by the Intergovernmental Affairs Committee, the Committee will forward the proposed agenda to the full City Council for consideration and adoption. Draft 2025 Legislative Agenda



The Legislative Agenda codifies the City of Long Beach's (City) positions on legislation, regulatory proposals, and funding opportunities. The purpose of the agenda is to align the advocacy efforts of the City's Government Affairs Office with the City's core values, principles, and policy statements covering a variety of issues that impact the City.

Each year, the Legislative Agenda is updated in consultation with the Mayor, City Council, and City departments to highlight the legislative and funding priorities for consideration and adoption by the City Council. The agenda provides direction to the Government Affairs Office and the City's legislative advocates on strategic objectives for the year, allowing the City to effectively take positions on specific policy issues that affect City operations.

The legislative agenda serves as a strategic plan that directs staff activities and advocacy priorities throughout the year. These priorities are driven by the City's core values of preserving local control over finances and decision-making; advancing equity and inclusion for communities most impacted by policy decisions at other levels of government; and ensuring the City's long-term resilience and adaptability in the face of growing environmental, economic, and public safety and health challenges.

Core Values

Equity and Inclusion

Equity is when everyone can reach their highest level of health and potential for a successful life, regardless of their background and identity. Inclusion means the practice of providing equitable access to opportunities and resources for people who might otherwise be excluded or marginalized. Each area of the legislative agenda is considered through a lens of advancing equity and inclusion. The City acknowledges the existence and impacts of historic systemic racism and ableism and supports equitable community practices through innovative local government models. We further support the use of an equity lens in policy and program design and will seek funding to increase inclusive access and equitable opportunity for all members of the Long Beach community.

Local Control

The City of Long Beach supports policies and legislation that protect and/or expand the City's authority and rights over its affairs. Staff will work to oppose policies and legislation that preempts the current authority possessed by the City and instead delegates that authority to the State and federal governments or other governmental jurisdictions. Local control gives leaders the flexibility to solve problems that are in the best interest of their own communities. This is vital for Long Beach to remain a unique place to live, work, and play.

Resilience and Adaptability

The City has been greatly tested by the global COVID-19 public health pandemic and the City's emergency proclamation to address homelessness. Resilience and adaptability are crucial as we continue to recover and adapt to ever changing surroundings. Resiliency is the capacity for communities and organizations to heal from trauma, and adaptability refers to the ability to cope with adversity and adapt to challenges or change.

2024 Focus Statements

While the Legislative Agenda contains City Council-adopted objectives and directives regarding a wide array of issue areas impacting the City, focus statements help to bring attention to funding and legislative priorities for the current legislative year. These statements highlight issues that need to be addressed throughout the year. Focus statements are developed in conjunction with various City departments and may shift from year to year based on the social, political, and economic environment.

The priorities outlined below are in line with the City's Strategic Vision 2030. To guide long-range decision-making and policy direction, the City developed the Strategic Vision 2030. The vision affirms and reframes the City's commitment to supporting the diverse Long Beach community and resolves to achieve a future in which all residents experience Long Beach as a safe, clean, and healthy place to live, learn, work, play, and thrive. The vision captures the insights, goals, and community voices that make up more than 30 City plans and initiatives developed in the past six years, as well as input from the Mayor, Council Members, City staff, and community members. The top three priorities established by the Mayor and City Council include housing and homelessness, economic development, and public safety.

Priority Legislative and Budget Items

- Support legislation and policies that make the Homeless Housing, Assistance and Prevention grant program allocation methodology more equitable to Long Beach.
- Support policies, legislation, and funding for the implementation of the Long Beach Housing Promise to increase housing and reduce homelessness.
- Support policies, legislation, and funding that allocate direct financial resources to mitigate the City's liability for oil well abandonment and expedite State savings for their abandonment costs in the Wilmington Oil Field.
- Support policies, legislation and funding to advance the transition of the City's waste-to-energy facility into a regional organics processing resource or other solution for the City's waste management needs.
- Support policies, legislation, and funding for the implementation of the Grow Long Beach Initiative.
- Support policies, legislation, and funding for the implementation of the Westside Promise to improve open space, public health, environmental health, and public infrastructure in West Long Beach.

- Support policies, legislation, and funding that allocate direct financial resources for mental health to jurisdictions with their own city-run health departments.
- Support policies, legislation, and funding that allocate direct financial resources to the City's Black Infant Health Program.
- Support policies and legislation that would raise the Area Median Income threshold for tenants in publicly owned and operated affordable housing projects to ensure middle-income households are not subject to possessory interest tax.
- Support policies and legislation that would prohibit loitering with the intent to commit prostitution and increase opportunities for victims of human trafficking to receive services.

Infrastructure

In 2028, the City of Long Beach will host events for the Olympic and Paralympic Games. In preparation, the City unveiled a plan, known as "Elevate '28", to build upon the five-year infrastructure plan and enhance City parks, major corridors, and visiting-serving areas. The Elevate '28 plan includes 64 new projects that will enhance park space throughout the city, continue to improve water quality, provide wayfinding signage, placemaking efforts, transportation and mobility improvements, and prepare to elevate the city to the international stage. The City will continue to advocate for external funding opportunities to revitalize the City's infrastructure and address the following critical infrastructure needs and projects:

- Support policies, legislation, and funding for the implementation of the Elevate '28 Infrastructure Investment Plan to revitalize the City's infrastructure in preparation for the 2028 Olympic and Paralympic Games.
- Support water quality infrastructure investments to improve the quality of stormwater, sustain wetlands habitats, and protect aquatic life.
- [Support resilient drainage and flood control infrastructure.](#)
- Support sustainable infrastructure funding to advance the City's climate resiliency efforts and organics waste objectives.
- Support policies, legislation, and funding for road improvements and other transportation infrastructure improvements to attract additional industries like private spaceflight and aerospace to the City.
- Support infrastructure investments that reduce long-term operations and maintenance expenditures for the City.
- Support regional planning and investments in electric vehicle charging infrastructure (both public and private) and zero-emissions equipment through robust grants and financial incentives.
- Support infrastructure investments to advance the Port of Long Beach's zero-emissions, Green Port Policy and Clean Air Action Plan objectives, meet current and future supply chain demands, relieve congestion and improve efficiency, increase on-dock rail, reduce emissions, and expand workforce development opportunities in trade-related sectors.
- Support streamlined funding to incorporate technology into infrastructure programs, including "dig once" and "build once" opportunities that modernize technology in City

and public facilities.

- Support the construction of and improvements to vital public safety infrastructure such as fire and police stations, health facilities, [radio infrastructure, technology infrastructure, interagency data-sharing](#) and emergency preparation and response resources.
- [Support for emergency medical services to be equitably delivered to visitors and residents, and mitigate service delays or reduction to 911 ambulance service in preparation and during the 2028 Olympic and Paralympic Games.](#)
- Support the development of a preventative and responsive public health infrastructure to identify early and respond swiftly to emerging infectious disease threats.
- Support funding for public facilities such as swimming pools, parks and open space, arts and cultural resources, and community centers in historically marginalized communities.
- Support investments to create housing opportunities for people experiencing homelessness, long-term affordable housing, and mortgage down payment assistance programs.
- Seek opportunities to facilitate economic development through leveraging private investments to promote quality infrastructure benefiting all communities within the City.
- Support the development of the Port of Long Beach's Pier Wind project to accommodate the assembly of offshore wind turbines on the West Coast.
- Support policies, legislation, and funding to strengthen and incentivize the hydrogen economy.
- Support legislation that provides direct City allocations for infrastructure projects and more local control and flexibility to meet the City's myriad infrastructure needs.

Recovery

Since March 10, 2020, when the City Council declared a local health emergency to address the COVID-19 pandemic, the City's top priority has been to mitigate the risks to residents' health and well-being, as well as impacts to the economy and the local business community. The City will continue to advocate for ongoing funding to support Long Beach Recovery Act programs, resources for the long-term economic recovery, upstream preventative solutions, and resilience of the City.

- Support legislation and funding to address the root causes of people experiencing homelessness, health inequities, and systematic racism to lessen the impact of future pandemics and other disasters.
- Support legislation and funding that prioritizes disaster prevention, preparedness, mitigation, and response in communities with the highest need.
- Support legislation and funding that will reduce the impact of climate change on the most vulnerable populations including older adults and people experiencing homelessness.
- Support legislation and resources to effectively respond to communicable diseases and mitigate the spread of the virus.
- Support ongoing, structural funding for public health jurisdictions to coordinate and

invest in public health infrastructure, workforce, equity, STD testing and prevention, and other local needs.

- Support resources for basic needs including food security, childcare, and access to transportation and work.
- Support funding that increases broadband access and adoption through devices, education, and affordable internet services.
- Support funding to invest in economic recovery in the sectors hardest-hit by the COVID-19 pandemic, employment opportunities, and economic research to study the impacts of the City's investment programs.
- Support resources for programs that build generational wealth for low-income communities such as homeownership opportunities and inclusive entrepreneurship.
- Support funding to assist low-income residents that utilize the City parks and libraries and their services by subsidizing access to park programs and eliminating overdue library fines.
- In coordination with Long Beach Water, support policies that make water debt relief funding to local water systems and customers non-taxable.
- Support resources for the City to expand language access during in-person and hybrid public meetings through funding for translation services, software and technology, and personnel.
- Support policies, legislations, and grants to strengthen investments that support comprehensive approaches to chronic disease prevention, including but not limited to, cardiovascular disease, cancer, hypertension, and type-2 diabetes.
- Support policies, resources, and programs that reduce the ambulance patient offload delays between the City's 911 emergency health ambulance units and regional hospitals.

1.1. **Emerging Sectors** – Grow and strengthen our established industry clusters and emerging sectors.

- Support policies, legislation and grants to increase the number of jobs and businesses in key industry clusters.
- Support policies, legislation and grants to increase the number of jobs in traded industries that bring wealth into Long Beach.
- Support policies, legislation and grants to increase research capacity and relevancy as measured by approved patents.
- Support policies, legislation and grants to increase tourism activity as measured by transient occupancy tax (TOT) [and/or sales tax](#) revenue.
- Support policies, legislation and grants that foster greater economic opportunity, including pursuit of Economic Development Administration (EDA), Environmental Protection Agency (EPA) and Brownfields Redevelopment Action Grant investment program funding.
- Support policies, legislation and grants to require the State's Employment Development Department to provide the same economic data they provide for counties to the ten largest cities in the state.
- Support the extension of State hiring and manufacturing tax credits.
- Support or sponsor legislation that allows the City of Long Beach to pursue public-private partnerships.
- Support policies, legislation and grants for funding for the City of Long Beach, Port of Long Beach, Long Beach Airport and Long Beach Transit for mass transit, transportation projects, and needed infrastructure.
- Support efforts to increase operational excellence in terms of balancing environmentally sustainable achievements and financial strength at the Port of Long Beach.
- Support legislation, grants, and greater partnership with the Governor's Office of Business and Economic Development (Go-Biz) that stimulate renewed, diversified economic, as well as manufacturing and export clusters in the [cCity](#).
- Support policies and legislation restoring the Glass-Steagall Act and, if necessary, repeal provisions of the Gramm-Leach-Bliley Act to restore integrity and trust in our financial system.
- Monitor legislation related to crypto currency or bitcoin regulation specific to businesses.
- Support policies, legislation and grants for investment programs that assist in the development of creative and tourism-related industries.
- Support policies and legislation to continue funding the EB-5 Immigrant Investor Program to stimulate the U.S. economy.

- Support policies, legislation, and grants that encourage technological innovation to improve opportunities for local businesses and advance economic development outcomes.

1.2. Economic Equity - Increase access to economic opportunities in low-income communities to advance economic equity.

- Support policies, legislation, and grants to increase the number of and non-traditional capital resources for minority-owned, LGBTQ+-owned and women-owned businesses.
- Support policies, legislation, and grants to increase investment in all business corridors with prioritization for underserved and low-income business corridors.
- Support policies, legislation, and grants to increase financial literacy and wealth building opportunities for young people, disadvantaged families, senior citizens, and local businesses, with emphasis on minority, LGBTQ+-owned and women-owned businesses.
- Support policies, legislation, and grants to increase the percentage of City spending on local businesses, with emphasis on minority, LGBTQ+-owned and women-owned businesses.
- Support policies, legislation, and grants to increase financial literacy and wealth-building opportunities for young people and disadvantaged families.
- Support policies, legislation, and grants to decrease the digital divide for underserved low-income community households.
- Support federal legislation that maintains existing allowances for undocumented immigrants who qualified for the Deferred Action for Childhood Arrivals (DACA) Program to remain in the United States, as well as any legislation that protects the safety and well-being of all Californians by ensuring State and local resources are not used to support deportations, collect information about an individual's religious beliefs or affiliations, and ultimately hurt California's economy.
- Support policies and legislation that support comprehensive immigration reform that will provide a dignified path to United States citizenship to strengthen the nation's workforce and the economy including qualifying undocumented youth with a conditional path to citizenship upon completion of a college degree or military service.
- Support policies and legislation to raise the federal minimum wage from \$7.25 to \$15.00 an hour.
- Support policies, legislation, and grants to grow small business activity, including targeted growth among "homegrown" businesses in Long Beach.
- Support legislation that would ensure new safety regulations be made available for review and comment by employers prior to implementation.
- Support policies, legislation, and funding to ensure language access across all government documents for cultural competency.
- Support resources and funding to facilitate the establishment of "economic" empowerment zones and the use of revolving loan funds to expand commercial and

cultural opportunities in designated zones for low-to-moderate income ~~-(LMI)~~ communities.

- Support legislation and resources to advance the creation of infrastructure financing districts and tax-increment financing to bolster the City's empowerment zones, expand the use of funds to maintain and administer the zones, and allow for property ownership opportunities for lower-income entrepreneurs.
- Support legislation that streamlines the administrative review process for exempting and excluding properties from the Surplus Land Act and clarifies the disposition of surplus land to mean sale, transfer, or long-term lease.
- Support efforts to enhance accommodations and accessibility in dwellings and businesses for all Long Beach residents.
- Support policies and legislation that protect workers' rights to organize, engage in collective bargaining, and negotiate with employers.

1.3. Workforce Preparedness - Ensure the preparedness of the workforce and the competitiveness of business through alignment of economic development, training, education, and community partner efforts.

- Support policies and legislation that will increase year over year per capita income in the City.
- Support policies, legislation, and grants to increase the number of middle and high-skill jobs in the City.
- Support policies, legislation, and grants to reduce the unemployment rate.
- Support policies and legislation to increase the share of adult population with a Bachelor's degree, post-secondary education, or completion of certified certificate programs.
- Support policies, legislation, and grants to increase the number of Long Beach residents who re-engage with the education and training system.
- Support policies to increase the number of CSULB and LBCC graduates that reside and work in the City after graduation.
- Support policies, legislation, and funding that would help California retain film industry jobs and associated economic benefits, including legislation to prevent runaway production.
- Support policies, legislation, and funding to assist museums, community arts programming and facilities.
- Support policies, legislation, and funding to assist the City in providing job training, community programming, with a focus on at-risk youth and reentry populations, as

well as long term unemployed residents both to receive training and reenter the workforce.

- Support policies and legislation that would permit local agencies to consider local hiring practices in projects supported with more than 50% non-federal funds.

1.4. Entrepreneurship - Build a supportive economic ecosystem that creates reliable pathways for entrepreneurs to confidently start and grow successful businesses.

- Support policies and legislation to reduce the cost of doing business and median days to approval for business licensing.
- Support policies, legislation, and grants to increase the number of active business licenses.
- Support policies and legislation to increase availability and access to high-speed internet throughout the City.
- Support policies, legislation, and grants to establish Long Beach as one of the most business-friendly cities in the world.
- Support policies, legislation, and funding to ensure workplaces offer health insurance to employees so that workers and residents of Long Beach have equitable access to healthcare.
- Support policies, legislation, and grants to increase the number and value of small business loans secured.
- Support efforts to ensure effective responses and resources for projects that support populations in particular need of interventions: e.g., emancipated foster youth, transitional aged youth, systems-involved youth, gang impacted youth, military veterans and spouses, re-entry populations, individuals with disabilities, disabled individuals, older workers, and transitioning workers who are dislocated workers.
- Support legislation and pursue pilot programs that expand workforce opportunities for immigrant communities in particular those that may utilize recent State measures related to undocumented youth and other measures that have sought to remove barriers toward self-sufficiency.
- Support legislation that allows cities/and or jurisdictions to incentivize or collect fees from users of the goods movement system and from parties that impact local air quality and the environment.
- Support the presentation of net neutrality to ensure that all internet service providers (ISPs) treat all internet traffic equally, regardless of content or application type.

1.5. Industry Needs - Support workforce development activities that align with industry needs.

- Support policies and legislation to maximize State allocated Workforce Development Board grants in the City of Long Beach.
- Support policies, legislation, and grants to retain, expand, and attract manufacturing, technology, health care, and other high-wage businesses, including regional approaches to workforce solutions that leverage regional planning, project delivery and industry convening/research efforts.
- Support policies, legislation, and grants to increase outcomes and relevancy of One-Stop Career Centers through resource integration with State “merit staff” systems and alignment of performance measures that increase the skills base of the workforce, consistent with adopted Demand Sectors and Self Sufficiency Standard.
- Support incentives that increase the marketability of unemployed or under-employed workers by supporting policies, legislation, and funding to assist employees in receiving training in emerging industries to maintain competitive employment.
- Support policies, legislation, and grants for a renewable energy worker training grant program, including the creation of an “Energy Conservation Corps” or similar program, to attract and retain local green collar jobs in industries such as green building, renewable energy technologies, and energy efficiency.
- Support efforts to obtain funds for job training, and other transition activities that are needed to be flexible to changes in the aerospace, aviation, and maritime industries.
- Support policies, legislation, and grants for the workforce development system, and encourage investment and development of the system’s one-stop centers, as well as training programs that address worker skill gaps in growing industries.
- Support policies, legislation and grants to facilitate the demonstration of zero emission (ZE) technology and facilitate the construction of ZE infrastructure and goods movement projects in Long Beach, while closely monitoring the availability and economic feasibility of goods movement industry green technology.
- Support policies, legislation, and grants to increase and stabilize investment in the local workforce development system, for the benefit of youth development with a special focus on the needs of out-of-school, those who are emancipated and enrolled in justice system programs, emancipated foster youth, military veterans (and spouses), re-entry populations, disabled individuals, older workers and transitioning dislocated workers.
- Support policies, legislation, and grants that creates a more competitive business environment for all Long Beach businesses.
- Support policies, legislation, and grants that promotes the development of space-oriented technology for commercial uses, space- oriented development, and space exploration.

- Support policies, legislation, and grants to sustain the investment made by the Department of Defense Office of Economic Adjustment to help transition the C-17 plant and parcels into a new center of economic activity and innovation.
- Support policies and legislation to provide paid parental leave to full-time employees.
- Support policies, legislation, and grants that assist families in gaining access to quality and affordable childcare.

This may include high-quality public transit, pedestrian, and bikeway systems, open space, tree canopy, recreational amenities, clean and safe drinking water, and other critical needs.
- Support policies to conduct inclusive and meaningful public outreach and engagement throughout planning, development review, and implementation processes.
- Support state-funded financing to supplement impact fees to pay for infrastructure, community benefits and services to reduce housing development costs.
- Support state programs that encourage remediation and redevelopment of brownfield and gray field sites.
- Support policies that strengthen regional planning and collaboration around issues at the regional or sub-regional level—such as affordable housing, air quality, greenhouse gas emissions mitigation, regional transportation, hazard mitigation and climate adaptation, and water management and flood control.
- Support policies that encourage or incentivize development in high resource areas such as mixed income housing incentives for developments in TCAC High Opportunity areas.
- Support policies that encourage streamlined environmental review, clarifying CEQA applicability as it relates to housing production and local land use decision making.
- Amend CEQA to exempt priority housing projects which are consistent with local plans, including Housing Element programs and RHNA obligations.
- Amend CEQA to provide exemptions for all projects with 100% affordable residential units.

- Amend CEQA to exempt emergency shelters and supportive/transitional housing.

- Support legislation that allows for local control of shopping cart retrieval
- Support legislation to reduce blight in neighborhoods by placing reasonable restrictions on utilizing vehicles solely for the purpose of advertisement.
- Support or sponsor legislation to extend the authority of the Long Beach Oversight Board of the City of Long Beach as the Successor Agency to the Redevelopment Agency of the City of Long Beach.
- Oppose policies and legislation to preempt the local government's current authority as it relates to bankruptcy proceedings.
- Support policies, legislation, and grants to fund e-government initiatives, including the ability to utilize Public, Educational and Government (PEG) franchise fee support for both capital and operational expenses.
- Support policies and legislation that allows State Infrastructure Bank Loans to be used for publicly owned acquisitions, including public-private partnerships.

- Protect existing funding and support for AB 109 and AB 117 public safety realignment programs such as partnerships with the probation department, referrals to employment, health and mental services, and enhanced resources for local public safety officials.
- Support policies, legislation, and grants to fund new and upgrade existing public safety equipment, facilities, and technology such as the operation of a real-time intelligence center.
- Support policies and legislation decreasing the state administrative cap for all federal grants and increasing the administrative cap for local governments.
- Support legislation, policies and funding to enable local law enforcement agencies to establish interoperable databases of ammunition and cartridge cases, including fingerprints found on ammunition and cartridge cases at documented crime scenes.
- Support legislation and grant opportunities for businesses, community groups, and/or business corridors who use CPTED deterrence efforts such as the clearing of brush, installation of roll downs, LED lights, camera/alarm upgrades.
- Support legislation that requires automobile manufacturers to install theft prevention devices and [pre-installed](#) front license plate holders for newly manufactured vehicles, and support incentive programs/grant opportunities that would allow qualifying victims to be partially reimbursed for their loss.
- Support legislation that standardizes social media platform retention periods for law enforcement access for criminal investigations and standardizes emergency requests.

9.2. **Innovation** - Foster innovation and partnerships to achieve safe and livable neighborhoods.

- Support legislation and policies that enable immigrants who arrived in the United States as children and who meet certain criteria to apply for work permits, as well as deferred action from deportation.
- Support proposals which would protect Deferred Action for Parents of Americans and Lawful Permanent Residents (DAPA).
- Support funding of innovative, non-traditional police service models for law enforcement and community safety to assist in response to non-emergency calls.
- Support policies, legislation and grants that promote the efforts of the City's gang prevention, diversion, and intervention programs.
- ~~Support federal policies that would be applicable nationwide to create a system that would enable medical cannabis to be distributed at accredited pharmacies.~~
- Support policies and legislation that provides more local government control over the regulation of drug and alcohol recovery facilities, including sober-living homes that rent up to six beds to recovering individuals and are not currently required to register for city business licenses, obtain conditional use permits or state licenses.

9.3. **Wellness** -With consideration of past trauma, foster employee, and community wellness to achieve safe neighborhoods.

- Support legislation that strengthens wellness for law enforcement employees and provides funding for recruitment, inclusivity, and retention of police.
- Support legislation and grant opportunities to fund innovative programs to enhance the life-work balance and mental health of peace officers, by providing local housing, recruitment incentives, and childcare stipends.
- Support legislation and resources that help to decrease rape kit, firearm and ballistic backlogs.
- Support legislation that provides resources and services for victims of human trafficking, sexual abuse, and rape, including support of the Sexual Assault Response Team (SART).
- Support grants and legislation to enhance safe passage programs for students and pedestrians.
- Support legislation, policies, and funding that would enable public health providers and partner agencies to provide treatment to mentally ill individuals who are unable to offer urgently needed medical care for him or herself due to a mental disorder as part of a grave disability.
- Support policies, legislation, and funding to enhance or promote the efforts of the City's gang prevention, diversion, and intervention programs.
- Support legislation and grant opportunities for youth programming to teach youth about communication, healthy habits, Cardiopulmonary Resuscitation (CPR), drug use, trauma, stress management, cybersecurity/human trafficking, and conflict resolution.
- Support proposals that promote and provide funding for prevention and reentry-based programming and services for justice-involved individuals.

- Support legislation, policies, and funding to establish restorative justice programs in juvenile and adult courts.
- Support policies, legislation, and funding to provide immigrant populations with due process protections, including legal representation for individuals facing deportation proceedings.

9.4. Constitutional Rights and Public Trust – Strengthen the public’s trust in law enforcement through accountability, open communication, and community inclusion.

- Support policies and legislation to provide funding for police departments and relevant services to strengthen community relations through community and youth police academies.
- Support policies, legislation and funding that promotes equitable treatment and protects the fundamental liberties of all people.
- Support policies and legislation for transgender inclusivity and oppose efforts for exclusive treatment of the transgender community.
- Support policies, legislation, and grants to cities to recruit a diverse law enforcement workforce to improve transparency, understanding, and effectiveness in serving all communities.
- Support legislation, policies, and funding to facilitate the lateral hiring of police officers to fill critical law enforcement vacancies.
- Support policies, legislation, and funding to allow public safety officer applicants to be permanent residents of the State and not necessarily naturalized citizens.
- Support resources to track information related to public safety officers that resign in lieu of discipline or termination, or those with multiple sustained complaints and/or violations.
- Support policies that propose baseline decertification standards statewide, including to decertify public safety officers when convicted of a felony.
- Support funding for the state-mandated public disclosure of police personnel files related to public safety officer misconduct, serious use of force resulting in death or great bodily injury, sexual assault, and job-related dishonesty.
- Support policies, legislation and funding allowing the City to participate in State policy reform efforts to establish a statewide database of complaints against police officers to inform hiring decisions, strengthen whistleblower protections for officers or staff reporting police misconduct, improve transparency around acts of misconduct to improve public trust, and remove provisions that prohibit people reentering society from accessing services, employment, and housing.
- Support policies and legislation that ensure civil liberties are protected.
- Support policies, legislation and grants that provide increased mental health and substance use treatment facilities, support resources and incarceration diversion strategies in the Southern California region (urgent care centers, police training).

9.5. **Partnerships** – Continue to develop partnerships and initiatives to work together to ensure a safe city for all people.

- Support funding for collaborative response and partnerships that will address quality of life issues in the community.
- Support legislation that provides funding and support to programs that promote trust and engagement with the community.
- Support the expansion of mental health hospitals to provide individuals with mental health, substance abuse, or cooccurring disorders the care they need to live fulfilling lives.
- Support legislation and funding that encourages partnerships and training with other law enforcement agencies for the continuity of public safety within the region.
- Support policies, legislation, and funding to provide funding for the creation of a regional task force to target fentanyl abuse.
- Support state funding for educational grants to help establish criminal justice programs at local high schools and community colleges to engage and help establish a future workforce representative of the local community.
- Support legislation and proposals to encourage partnerships between law enforcement agencies or relevant services and academia to benefit juvenile diversion and anti-recidivism through educational attainment.
- Support or sponsor legislation and pursue funding for multi-sector collaborative approaches to violence prevention and public safety, recognizing the continuum of services that are responsible for public safety and prioritizing multi-sector data sharing initiatives that do not compromise confidential or sensitive information.
- Support legislation and grants to invest in upstream violence prevention strategies through programs like CalVIP, supporting living wage jobs, affordable housing, healthy communities and other social services that will ensure sustainable violence prevention.
- Support policies, legislation, grants and regional initiatives to support school campus safety, initiatives.
- Support policies and legislation that reduce the percentage required for passage of public safety bonds to the same percentage as school bonds (55%).
- Support legislation that would fund and/or incentivize multi-agency collaborative models of law enforcement through partnerships with community health workers and mental health professionals.
- Support policies, legislation, and funding for implicit and racial bias training for all law enforcement, de-escalation training that focuses on alternatives to deadly force, and training that focuses on alternatives to deadly force, and training to promote cultural and community awareness.
- Support the funding and use of regional task forces to combat organized crime involving robbery, commercial burglary, human trafficking, sex trafficking, and ~~retail theft/smash-and-grabs~~ motor vehicle theft.
- Support policies, legislation, and funding to strengthen capacity, resources, and visibility of local community-based violence prevention/intervention models and

gang outreach programs, including intervention workers, youth employment programs, summer programming, safe passages, and other best practices.

- Support legislation and regional initiatives that recognize and provide funding for safe communities as it supports collaboration between public safety and health, particularly violence prevention efforts and mental health treatment.
- Support policies, legislation and grants that promote the installation of fire sprinklers in existing structures.
- Support policy changes that recognize and promote mental health services as part of the gun control law discussion.
- Support legislation and policy that would require background checks on ammunition purchases.
- Support legislation, policy and grants that would enable the U.S. Centers for Disease Control and Prevention to fund gun violence studies and data collection.
- [Support legislation, policy and funding that supports gun safety education to securely store firearms.](#)
- Support legislation, policies, and grants for restorative justice programs.
- Support legislation, policy, and grants that support implementation of family and community violence prevention programs.
- Support legislation, policies, and grant opportunities for community-based programs to expand and incentivize justice-involved individuals, especially youth, to participate in restorative justice and diversion programs.

9.6. **Emergency Preparedness** – Continuously prepare for and respond to community needs in the event of emergency, pandemics and naturally occurring disasters

- Support legislative efforts to maintain local control of, incorporate technology into, and improve municipal public safety services, local law enforcement, fire suppression and prevention, hazardous materials mitigation, rescue, emergency medical services and disaster preparedness initiatives to enhance the ability for local public safety units to respond to, prevent, and prepare for terrorist threats.
- Support policies, legislation and funding to implement or improve upon natural disaster early warning systems [and early bio-detection programs.](#)
- [Support policies, legislation, regional initiatives and funding to advance equitable and inclusive emergency response efforts for vulnerable populations.](#)
- [Support policies, legislation, regional initiatives and funding to strengthen equitable and inclusive community resilience strategies.](#)
- Support policies, legislation and funding to authorize and fund regional interoperable public safety radio communications.
- Support policies, legislation and grants to fully fund technologies that provide the public with enhanced forecasting of natural disasters [and report public safety emergency needs \(e.g., text to 9-1-1\).](#)

9.7. **Technology** – Embrace technology to enhance public safety services

- Support policies and legislation to make State law enforcement grant funding less restrictive and allow greater discretionary use of funds for staffing, including those benefitting jail, data management and technology functions, and reimbursing overtime costs paid to public safety personnel who are required to appear in State and/or County courts.
- Support legislation that advances artificial intelligence technology use for public safety that is ethical, transparent, and trustworthy.
- Support policies, legislation, and funding to authorize and fund regional interoperable public safety radio communications.
- Support policies, legislation, and grants to fully fund technologies that provide the public with enhanced forecasting of natural disasters.
- Support policies, legislation, and funding to provide the public with enhanced or alternate technologies to report public safety emergency needs (e.g., text to 9-1-1).
- Support policies, legislation, and grants to provide funding for innovative crime fighting strategies, including through cross-departmental or multi-sector collaboration.
- Support policies, legislation, and grants to ensure that the City and Region receive necessary funding to develop, implement and maintain a regional communication system to ensure interoperable communications across disciplines and jurisdictions.
- Support legislation that would require police data reporting, if funding is available to sustain data collection.
- Support policies, legislation and grants that makes it easier for departments and organizations to share data to support cross-sector approaches to addressing safety and improving wellness.
- Support legislation that assists local governing authorities in mitigating the impacts of unmanned aircraft systems on critical infrastructure.

10. TECHNOLOGY

10.1. **Digital Inclusion** – Advance economic and digital inclusion equity for residents, workers and businesses

- Support policies, legislation and grants to increase the number of households and businesses which have access to low-cost or free high-speed and reliable Internet as

well as low-cost or free quality, Internet-enabled technology devices and technical support.

- Support policies, legislation and grants to increase the number and location of City provided public Wi-Fi services and community-focused computer labs.
- Support policies and legislation that seek to restore local control in regulatory matters concerning Internet telecommunications, including instituting requirements for Internet Service Providers to share data on infrastructure and subscribers with the City to assist in Dig Once coordination and assess equitable access to the Internet.
- Support policies, legislation and grants that treat Internet access as an eligible utility for State housing vouchers and other subsidies.
- Support policies, legislation and grants to increase the availability of free multilingual digital literacy training and support, job preparedness and digital literacy skill development.
- Support policies, legislation and funding that protect consumer privacy and a free and open Internet, to ensure interoperability, inclusion and opportunity in digital services.
- Support policies, legislation and funding that ensure transparency, accountability and non-discrimination of data, content and algorithms.
- Support policies, legislation, and funding that promotes digital accessibility and inclusivity practices.
- Support policies and legislation that protect Customer Proprietary Network Information (CPNI) by prohibiting broadband Internet access service providers from using, disclosing, or permitting access to individually identifiable personal information.
- Support policies, legislation and grants to increase funding and resources for the City's Digital Inclusion efforts for residents, workers and business owners.
- Support policies, legislation and funding to increase ongoing Internet access as an eligible utility for federal housing vouchers and other subsidies.
- Support policies and legislation that opens Internet connections subsidized by the federal E-Rate program, currently only allowed for schools and libraries.
- [Oppose funding cuts and eligibility changes to the Digital Equity Act grant programs.](#)

10.2. Telecommunications

- Protect local government's ability to facilitate advanced communication services to their citizens.
- Support legislative efforts to ensure that the City has local nuisance abatement control over the visual blight that is created by excessive deployment of cable and telecommunication wires and related facilities.
- Support policies and legislation or request an amendment to California Public Utilities Commission (CPUC) rules and regulations to ensure that the City has the authority to abate visual blight that is created by cable television service wires and

related equipment that are in place and open to public view when these wires and related equipment are not actually being used for their intended purpose.

- Support policies and legislation to provide free public Wi-Fi in parks, beaches, and venues in preparation for the 2028 Olympic and Paralympic Games.
- Support policies and legislation to expand fiber capacity throughout the City to provide communities with high-speed Internet access, connect City facilities to the internal City network, and expand the Citywide camera network.

10.3 Cybersecurity

- Support expanding StateRamp as a resource to California government agencies to standardize Statewide cyber security standards and enable the City to confidently partner with vendors who are vetted as providing secure cloud-based systems.
- Support policies and legislation to enhance the City's ability to defend against cyber-attacks via Security Operations Center (SOC) processes, procedures, and technology.
- Support policies and legislation to manage and maintain the necessary technology and procedures required to ensure business continuity and rapid service restoration in the event of a disaster.
- Support policies, legislation and funding that provide for residents, workers and businesses to safely access the Internet through cybersecurity training and resources.
- Support policies, legislation and funding that -protects the public's digital privacy rights, safeguards the security and control of access to personal data and technological systems, and secures the public's trust in utilization of new and emerging technologies.

10.4 Artificial Intelligence

- Support policies, legislation, and funding that advances the development and use of artificial intelligence (AI) systems for social good, improvement of government services, and ethical, non-discriminatory, and responsible AI governance.
- Support cooperative purchasing efforts for AI systems and tools among government agencies.
- Support policies, legislation, and funding that promote workforce development and resilience through AI training and skill development.
- Support policies and legislation that promote AI system vendor accountability, reporting, and transparency.

11. TRANSPORTATION

11.1. Active Transportation and Transit-Oriented Development

- Pursue policies, legislation and grants to improve, beautify, maintain, and increase

the safety of the I-710 Freeway, which serves as a vital thoroughfare for residents, businesses and commerce, including funding for I-710 Early Action Projects, beginning with the realignment ~~of the Shoemaker Bridge and ramps of Shoreline Drive and the replacement of Shoemaker Bridge.~~

- In addition to local I-710 Early Action Projects, support efforts to maintain and enhance funding for Alameda Corridor East projects.
- Support policies and legislation to explore, fund, and construct zero emissions, near zero or the best available technologies for infrastructure and goods movement projects in Long Beach.
- Support policies, legislation and grants to increase funding for infrastructure improvements that improve connections to and facilities around public transit, buses, and Metro Lines (i.e. the A Line).
- Support policies, legislation and funding to promote and provide funding for housing, active transportation and mobility projects oriented around transit developments.
- [Support policies, legislation and funding to provide free transportation \(such as Metro LIFE or Long Beach Transit GoPass\) to youth for educational and recreational prosocial development activities.](#)
- Support opportunities to provide and improve active transportation infrastructure, and to increase access, safety, and equity.
- Support policies and legislation that maximizes equitable access to shared micromobility.
- Support opportunities for housing, active transportation and mobility projects oriented around transit developments.
- Support standardized data collection for shared mobility services, including e-scooters, bike share, ride share, etc. in order to support City equity and mobility objectives.
- Support the advancement of advance context-sensitive, streamlined approaches to right-of-way under State jurisdiction.
- Support an equitable distribution of regional transportation dollars to cities, as well as legislation that increases funding for transportation programs and projects in Long Beach.
- Support policies and legislation to ensure that the City maintains right-of-way control and allows our City to collect fair compensation for its use.
- Support funding sources and policies that increase local agencies' ability to create public plazas, public art, and other placemaking opportunities in the public right-of-way.
- Support policies, legislation, and funding to increase access to active transportation modes to reduce greenhouse-gas emissions from automobiles.
- Support funding sources that enhance pedestrian pathways for safe, accessible connections between neighborhoods and their parks and between bike ways, public transit, and the park network.
- Support policies, legislation and grants to improve local transportation

infrastructure, including: local and regional bicycle and pedestrian mobility networks, complete bicycle and mobility projects, pedestrian and bicycle safety projects, and [incorporation of storm-water ~~projects~~ improvements associated with these projects](#) in Long Beach.

- Support policies, legislation and grants to increase transit ridership through education and funding for transit-oriented development projects.
- Support the City's adopted plans and actions to improve bike, pedestrian, and traffic safety.

11.2. Roadway Safety

- Allow local jurisdictions to enact a 20MPH prima facie speed limit in high-injury networks, commercial districts, school zones, and residential districts.
- Support automated and unarmed enforcement as an alternative to armed law enforcement of California Vehicle Code and fee and fine structures that consider violators' ability to pay.
- Support revisions to the state collision reporting systems to reflect street safety and complete streets policy priorities.
- Support restrictions of Longer Combination Vehicles (LCVs) consisting of longer double tractor and triple tractor-trailers from traveling on State highways and freeways to improve traffic congestion and prevent fatal crashes.
- Support robust financial incentives and rebates for smaller and safer forms of personal vehicles for commuting and other travel, including passenger cars and e-bicycles.
- Support policies and legislation that will strengthen penalties for traffic violations in school zones in an attempt to reduce speed of drivers and protect youth.
- Support legislation, policies, and funding to establish [and expand](#) pilot programs for automated traffic speed [and vehicle noise](#) enforcement in high-injury networks and specific locations near schools, senior zones, public parks, and recreation centers.
- Support policies and legislation that would grant discretion to local government Traffic Engineers to make the final determination of a safe and reasonable speed limit.

11.3. Safe Streets Long Beach (Vision Zero)

- Support policies, legislation, and grants for the implementation of the Vision Zero Action Plan to meet the goal of zero traffic fatalities and serious injuries.
- [Support policies, legislation, and grants to update existing roadway design standards to reduce roadway injuries and fatalities.](#)
- [Support policies, legislation, and grants to update existing vehicle design standards to reduce roadway injuries and fatalities by considering pedestrian safety and the safety of other vehicles.](#)
- Participate in policy reform efforts to enable automated speed enforcement and provide more control to municipalities over the setting of speed limits, including

FHWA-endorsed methods that focus more on context and presence of vulnerable roadway users.

- Support policies or legislation to update California Highway Patrol's Form 555 to include additional fields related to vehicle type/user and contributing factors such as speeding-related (i.e., too fast for conditions), distracted driving, micromobility, vehicle for hire, bicyclist location at time of collision, and bicycle impact point to allow the City to more accurately identify engineering, education, and enforcement actions to improve safety.
- Support policies, legislation, and grants to create opportunities to collaborate with Caltrans to identify safety and complete streets improvements along its facilities.
- Support policies and legislation to restore local control for design at intersections shared with Caltrans to expedite projects which improve safety and complete streets designs along its facilities.
- Support policies, legislation, and grants that prioritize road safety investments through an equity lens.
- Support policies, legislation, and grants that fund public education campaigns and enforcement programs to reduce distracted and drug-impaired driving and improve roadway safety.
