DISCUSSION

The City of Long Beach (City) is an entitlement community for three funding programs administered by the U.S. Department of Housing and Urban Development (HUD): Community Development Block Grant (CDBG); HOME Investment Partnerships Program (HOME); and Emergency Solutions Grant (ESG). The fiscal year (FY) 2022-2023 Consolidated Annual Performance Evaluation Report (CAPER) describes the City's affordable housing and community development activities carried out from October 1, 2022 through September 30, 2023.

The CAPER also provides the community with a funding evaluation for the activities undertaken, and the City's progress toward the goals and objectives as stated in the 2023-2027 Five-Year Consolidated Plan and the FY 2022-2023 Action Plan. In FY 2022-2023, CDBG funding supported the implementation of several new programs, including the Neighborhood Grant Program, which awarded nine matching grants to neighborhood groups for events and projects, as well as a number of ongoing programs, including Small Business Assistance, Graffiti Removal and Security Deposit assistance programs. In addition, HOME and other housing funding investments in FY 2022-2023 have resulted in the development of 592 affordable units that are underway. ESG funding assisted 1,340 persons experiencing homelessness across the Rapid Rehousing, Emergency Shelter and Street Outreach programs.

To maximize the impact of the City's HUD funding and to further its Consolidated Plan goals and objectives, the City also leveraged a number of non-HUD programs and resources by applying for \$15,250,000 in federal and state grant funding, of which \$5,250,000 has been awarded. Other accomplishment highlights include the City's

receipt of its Prohousing Designation from the California Department of Housing and Community Development as well as the launch of new webpages to assist tenants and landlords in understanding their rights and responsibilities.

The accomplishment summary and presentation provided today will summarize outcomes for FY 2022-2023 (Attachments A and B).

FY 2022 - 2023 Consolidated Annual Performance Evaluation Report Accomplishment Summary

DECEMBER 2023



Long Beach is designated as an entitlement community for three funding programs administered by the U.S. Department of Housing and Urban Development (HUD): Community Development Block Grant (CDBG); HOME Investment Partnerships Program (HOME); and Emergency Solutions Grant (ESG). The FY 2022-2023 CAPER describes the City of Long Beach's affordable housing and community development activities carried out from October 1, 2022 through September 30, 2023.

CDBG PROGRAM ACCOMPLISHMENTS:

Graffiti Removal: A total of 196,072 graffiti tags removed from 74,750 sites.



Sidewalk Replacement Program: A total of 40,712 square feet of sidewalk and 2,784 linear feet of curb and gutter replaced and 62 curb ramps constructed.



Neighborhood Resource Center: A total of 5,780 neighborhood newsletters and 16,461 other neighborhood association documents were produced and disseminated.



Fair Housing Education: A total of 1,716 Long Beach residents and landlords were assisted with fair housing education and referrals.



Business Technical Assistance: Small Business Development Center assisted 939 local neighborhood businesses with workshops and one-on-one guidance and support.



Tree Planting: A total of 602 trees were planted citywide, with 488 in CDBG areas.



Home Improvement Roof Grant Program: A total of 63 eligible applications are being processed. A total of 39 property inspections have been conducted and contractor bidding has begun for roof replacement projects.



Enhanced Commercial Façade Program: A total of 44 eligible applications are being processed for the external rehabilitation of businesses.

Security Deposit Assistance: Provided funds to 12 low-income households.

Rental Assistance: Provided funds to 7 low-income households.

Neighborhood Grant Program: Awarded 9 matching grants to neighborhood associations to host neighborhood events and projects.

A total of 120 residents and neighborhood associations participated in grant writing and technology training workshops.

West Place-Based Neighborhood Improvement Strategy: Provided enhanced recreation space at Admiral Kidd Park.

South Place-Based Neighborhood Improvement Strategy: Addressed walkability and neighborhood blight near the Anaheim corridor.

Pathways to Removing Obstacles to Housing (PRO Housing): Application submitted to the U.S. Department of Housing and Urban Development (HUD) for \$10 million.

Permanent Local Housing Allocation (PLHA): Awarded over \$5 million by the California Department of Housing and Community Development (HCD).

Community Land Trust (CLT): Executed a two-year, \$800,000 contract with Long Beach Residents Empowered (LiBRE) to establish CLT.

Southern California Association of Governments' (SCAG): Awarded \$250,000 from the Housing Infill on Public and Private Lands Pilot Program to fund the expansion and update of the City's Inclusionary Housing Ordinance.

Neighborhood Clean-Up: A total of 2,927 volunteers removed 882 tons of trash and dumped items from neighborhood streets and alleys at 105 clean-up events.

Neighborhood Leadership Program: A total of 30 residents graduated from the multilingual Neighborhood Leadership Program Class of 2023 and completed four class projects along Anaheim Street.

New Webpages: Launched a new Tenant and Landlord Resources webpage, as well as a new Substantial Remodel Tenant Displacement webpage. These will help both tenants and landlords access current information and resources related to tenant and landlord rights and responsibilities

Prohousing Designation: Received designation from the California State Department of Housing and Community Development (HCD).

Background

- The fiscal year (FY) 2022-2023 Consolidated Annual Performance Evaluation Report (CAPER) describes the City of Long Beach's affordable housing and community development activities carried out from October 1, 2022 through September 30, 2023.
- The CAPER also provides the community with a concise statement regarding the U.S. Department of Housing and Urban Development (HUD) funds available for the activities undertaken, and an evaluation of the City's progress in carrying out the goals and objectives as stated in the Five-Year Consolidated Plan FY 2023 – FY 2027 and the FY 2022-2023 Action Plan.
- The CAPER is also a useful tool in evaluating program performance and spending as we look to the next Action Plan year.
