Executive Summary

On August 12, 2024 and August 19, 2024, staff published the Notice Inviting Bids for the Equipping of Water Wells Alamitos 9A and Alamitos 14 Project (O-0749) as required by Public Contract Code Section 22037. This project is for the equipping of the two new wells recently drilled within Stearns Champions Park and the last of two phases of construction of the wells. The work includes installation of new pumps, motors, and columns for both wells; installation of associated electrical and instrumentation equipment; installation of above and below ground piping to connect to the existing collection main system; and performing all related site improvements.

On August 29, 2024, three bids were received and opened, and the bid tabulation is attached. After evaluating all bids received, the lowest responsive bid submitted by Houalla Enterprises Ltd., dba Metro Builders & Engineers Group, Ltd., in the amount of \$6,851,086, was found to be in conformance with the bid documents.

The Engineer's Estimate is \$7,095,300.

Fiscal Impact

The cost to the Water Fund will be incurred in FY 25 and FY 26, with the total amount not to exceed the contract total of \$6,851,086. These costs are included in the Water Fund FY 25 CIP Budget and financial projections.



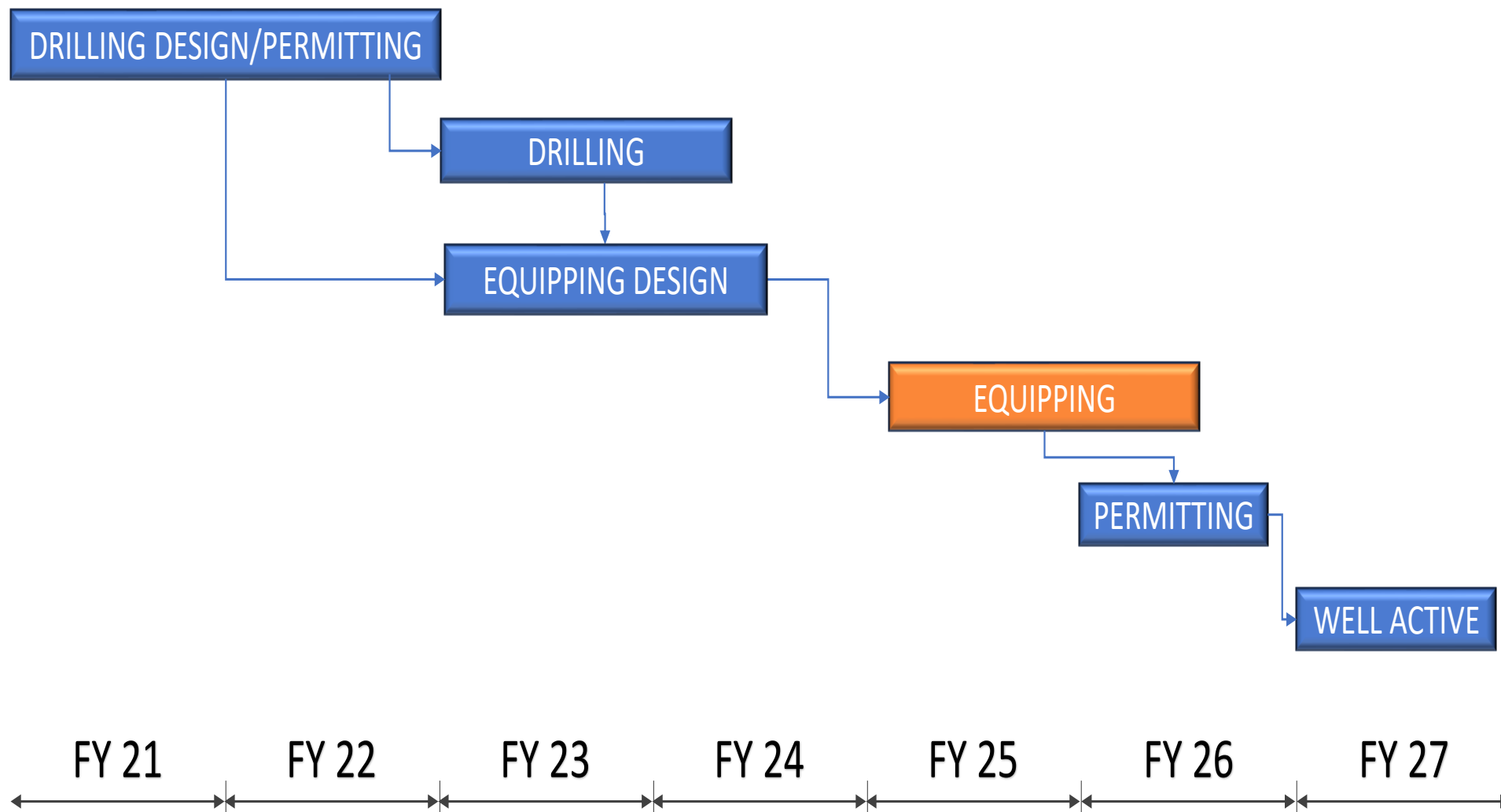
