Executive Summary


Over the past three years, the automotive industry has faced significant delays in vehicle production due to ongoing supply chain constraints, particularly in the medium-duty truck market. The Long Beach Utilities Department (LBUD) currently operates a fleet of 54 medium-duty trucks for Water and Sewer Utilities. Of these, 30 are more than 10 years old, with an additional 12 trucks approaching the 10-year mark.

In response to projected supply chain challenges, on November 9, 2023, the Board of Utilities Commissioners (Board) authorized staff to expedite fleet replacement by purchasing 42 medium-duty trucks. This proactive approach aims to ensure operational continuity over the next five years while allowing time for the medium-duty vehicle market to stabilize.


Of the 42 trucks acquired, 40 required service body modifications tailored to specific operational needs, resulting in 12 distinct service body designs. Bid Solicitation UD-24-175 was published on Long Beach Buys on July 3, 2024 and closed on July 24, 2024. Four bids were received; however, one was disqualified due to non-conformance with the bid specifications. Of the three conforming bids, SouthWest Structures, Inc., was identified as the lowest bidder.

Fiscal Impact

The unbudgeted cost to the Water and Sewer funds will be incurred in FY 25, with the total contract amount not to exceed \$1,552,900. After reviewing the FY 25 financial projections, staff has reprioritized non-critical CIP projects to ensure that funding is available for this essential expense. The purchase can be absorbed within the FY 25 Water and Sewer funds without negatively impacting overall financial stability.


